SUN VILLAGE TRIBAL POLICE CHARTER

(ENFORCEMENT DIVISION OF THE BANI AL-SHAMS GOVERNMENT)

Filed Under Divine Jurisdiction — Nunc Pro Tunc, In Perpetuity

PREAMBLE

We, the sovereign tribal government of Sun Village California (Bani Al-Shams), in recognition of the need for indigenous and covenant-based security, do hereby establish the **Sun Village Tribal Police** under full divine and tribal authority. This charter serves to define the lawful power, scope, and mission of our enforcement division — entrusted with the sacred duty of protecting the land, bloodline, and estate of our sovereign nation.

This is a charter of defense, not of aggression. Its origin is not in coercion but in covenant. No man or agency may interfere with the execution of these protections without invoking the full weight of URR®™, tribal immunity, and divine judgment.

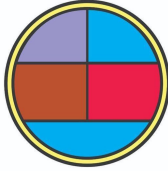
ARTICLE I: ESTABLISHMENT & PURPOSE

1. This document formally **charters the Sun Village Tribal Police** as the exclusive enforcement and protective authority of:
 - The **Sun Village Tribal Government**
 - The **Sun Village Trust** and all subsidiary trusts
 - The **Sun Village National Registry**
 - The **Sun Village Land & Property Declarations**
 - The **URR®™ Framework** and all sovereign instruments filed under it

2. The Sun Village Tribal Police exists to enforce:

- Tribal law
- Divine law
- URR®™ codified rights
- Customary indigenous protocols
- Protection orders filed under SVSP or the judiciary council

ARTICLE II: JURISDICTION & REACH

1. The jurisdiction of the Tribal Police extends to:

- **All land and property claimed under tribal declaration**
- **Digital territories and online platforms governed by tribal authority**
- **Tribal members and affiliates registered under the Sun Village National Registry**
- **Documents and instruments issued under URR®, SVSP, or Tribal Judiciary**

2. The Tribal Police may operate across **all territories** where enforcement of tribal instruments or protection of sovereign rights is required.

ARTICLE III: AUTHORITY & POWERS

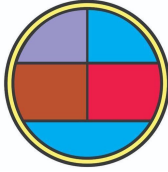
The Sun Village Tribal Police shall be empowered to:

- Investigate and document violations against tribal law, persons, or property
- Enforce tribal protection orders, no-trespass declarations, and sovereign injunctions
- Issue citations and enforcement notices for violations of URR®™, GFS, or other tribal mandates

- Detain individuals or entities who pose an immediate threat to the peace or sovereignty of the tribal estate
- Serve documents on behalf of the Tribal Judiciary, SVSP, or designated signatories
- Protect tribal elders, witnesses, properties, and sacred lands from encroachment or exploitation

All actions must be recorded and filed under **SVSP enforcement record** protocols.

ARTICLE IV: PROTECTIONS & IMMUNITIES

1. All officers, agents, and deputized enforcers of the Sun Village Tribal Police shall be granted:
 - **Full immunity** from civil, criminal, or commercial retaliation while acting in good faith and in line with this Charter
 - **Recognition under URR®™** as lawfully empowered agents of a sovereign tribal government
 - **Protected status** as enforcement agents under the jurisdiction of the **Sun Village Judiciary Council**
2. No foreign agent, court, or corporation may summon or prosecute a tribal officer without violating international protections under **UNDRIP**, **URR**, and **customary law**.

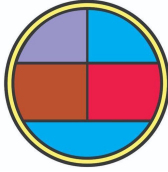
ARTICLE V: APPOINTMENTS & COMMAND

1. Officers may be appointed by:
 - The **Tribal Council**
 - The **Sun Village Judiciary**
 - A Sovereign Signatory or Elder under Executive Order
2. All appointments must be:

- Filed with digital signature under Notice of Digital Identity & Authority

ARTICLE VI: UNIFORMS, BADGES & EQUIPMENT

- The Sun Village Tribal Police shall maintain:
 - A distinct tribal insignia or badge
 - Custom identification (ID) cards
 - Digitally traceable enforcement orders and QR-tagged incident reports
 - Equipment necessary for security and protection, including surveillance, communication, and transport tools

The issuing of firearms or defensive tools shall remain under the **MHM Firearms Trust** and only for sanctioned operations.

ARTICLE VII: ACCOUNTABILITY

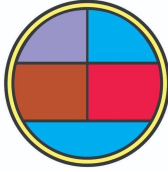
- All enforcement activities must be:
 - Logged into SVSP record system
 - Subject to review by the Tribal Judiciary Council
 - Transparent to tribal members under oath of responsibility

Abuse of power will result in immediate revocation of authority and penalties per URR®™ and GFS terms.
