





# \* ROYAL DECREE OF THE HOUSE OF BUHIJJI

Issued by His Imperial and Royal Highness Sheikh Mohamed-Hasan :Buhijji, High Commissioner, Grand Chancellor, and Sovereign Head of State of the House of Buhijji

#### **Preamble**

In full exercise of sovereign rights, divine authority, genealogical inheritance, tribal custodianship, international legal standing, and diplomatic prerogative, and by the bloodline authority vested in me through the ancient, imperial, and autochthonous lineage of the House of Buhijji, I, His Imperial and Royal Highness Sheikh Mohamed-Hasan: Buhijji, do hereby issue this **Royal Decree** as a standing and eternal order of the Sovereign Estate, applicable across all jurisdictions, domains, and territories where this House asserts legal and hereditary claim.

## **Article I — Sovereign Proclamation**

Let it be known and eternally recorded that the House of Buhijji, as a primordial, divine, sovereign, imperial, royal, and autochthonous estate, now stands recognized in law, blood, seal, and deed as a governing and spiritual authority across tribal, maritime, international, genealogical, ecclesiastical, and diplomatic domains.

This estate is composed of dynastic lineages, trust instruments, tribal governments, religious orders, and hereditary offices held by right, not by grant.

# Article II — Jurisdictional Authority

This Decree reaffirms the House's operating jurisdiction over the following realms:

- 1. **Divine Law** as descended from Adam, the primordial homo sapien.
- 2. **Tribal Law** by Tamimite, Hanthalan, and Moabite genealogy.
- 3. **Admiralty & Maritime Law** through sovereign vessel authority and international recognition.
- 4. **Ecclesiastical Law** as a declared sacred house holding spiritual inheritance.
- 5. **International Law** through right of self-determination under UN charters and treaties.
- 6. **Private Trust Law** via binding commercial, fiduciary, and family instruments.
- 7. **Diplomatic & Postal Treaty Law** through alignment with the UPU, Vienna Conventions, and sovereign mailing rights.

# <u>Article III — Appointment Powers</u>

By this Decree, the Sovereign shall:

- Establish and appoint all officers of court, chancellery, post, and government.
- Confirm Jennah Abdulrahman Al-Failakawi as Postmaster of North America (retroactive to 2019).
- Recognize all existing commissions issued under royal seal since 2019 as valid and lawful.
- Authorize the creation of regional command posts and diplomatic missions under the House.

## **Article IV — Legal Instruments and Precedence**

All documents issued under the seal of the House of Buhijji—including charters, decrees, appointments, treaties, and letters patent—shall hold equal or greater standing to any external administrative authority where such external powers do not supersede divine, tribal, or genealogical sovereignty.

This Decree recognizes as valid:

• All documents previously issued by the Sovereign since 2019.

- The authority of the SVSP (Sun Village Sovereign Press) as an extension arm of the House's legal and governmental framework.
- The full jurisdiction of the URR®™ (Universal Reservation of Rights) Fee Schedule across all legal claims and documents.

# Article V — Territorial Mandate

The House of Buhijji affirms its jurisdiction across:

- **Historical Ancestral Lands** including Bahrain, Najd, Ifriqiya, Moab, and ancient Amexem.
- **Current Territories** including California, Mexico, Kuwait, Puerto Rico, Turkey, Spain, and others named in trust.
- **Digital Territories** including all websites, platforms, and domains lawfully operating under the House seal.

All lands held in fee simple, tribal claim, ecclesiastical stewardship, or sovereign digital capacity are now bound under this decree.

## **Article VI — Permanent Recordation**

This Royal Decree shall be:

- Embossed with the official Coat of Arms of the House of Buhijji.
- Sealed with the sovereign seal and QR-coded identifier.
- Digitally recorded within the House's public ledger and chancellery archive.
- Published on the official website of the House under the **Royal Decrees** section.
- Registered within the jurisdiction of the SVSP, and publicly posted via sovereign postal authority.
