APPENDIX VIII - TERRITORIAL ERASURE AND THE CARTOGRAPHIC THEFT OF HOMELAND

Annexed to the Declaration of Restoration of the Ben-Ishmael Nation Filed under the Authority of the Sun Village California Tribal Government (Bani Al-Shams)

I. PURPOSE

This appendix exposes the **systematic territorial erasure** of the Ben-Ishmael Tribe through map forgery, boundary redistricting, and cartographic colonization. It identifies how our sovereign lands — including key tribal strongholds like **Morocco, Indiana** and **Sun Village, California** — were **stripped of identity, rebranded under settler frameworks**, and their rightful owners declared non-existent.

We establish that **our homeland was not merely lost, but stolen**, erased by the deliberate manipulation of legal descriptions, census boundaries, treaty geography, and jurisdictional labels.

II. STRATEGIES OF TERRITORIAL ERASURE

- 1. Redistricting and County-Level Reclassification
 - Ben-Ishmaelite lands were redistricted out of tribal oversight, shifted into:
 - Newly created counties
 - Non-incorporated zones
 - Land banks and state trust holdings
 - Townships like **Beaver (IN)** and **Sun Village (CA)** were **severed from regional continuity**, then rebranded as underserved zones, thus:
 - Deleting tribal infrastructure from public maps
 - Reassigning jurisdiction to hostile local governments
- 2. Forged Cartographic Designations
 - Tribal markers, borders, and topographies were:
 - Removed from official atlases
 - Falsified in legal surveys
 - Marked as "empty," "barren," or "abandoned" despite vibrant tribal presence
 - Mapmakers colluded with state engineers and railroad companies to rename tribal settlements, often assigning:

- New English names (e.g., "Cedar," "Freedom," "Liberty")
- Surveyor labels like "Tract 54-XY"
- ZIP codes without postal service, to simulate federal recognition

3. Elimination of Tribal Toponymy

- Sacred toponyms rooted in Arabic, Berber, and Amerindian names were:
- Deliberately anglicized or eliminated
- Misclassified under euphemisms like "negro camps," "white trash lanes," or "gypsy flats"

Examples include:

- $al\text{-}Wadi \rightarrow \text{``Dry Creek''}$
- *Ishmael Settlement* → "Orphan's Hollow"
- *Qaryah al-Shams* → "Sun Valley / Sun Village" stripped of its tribal etymology

4. Infrastructure Suppression

- Tribal roads, wells, mosques, caravan routes, and cemeteries were:
- Bulldozed for railroads, power lines, and pipelines
- Replotted as private or military land
- Left off city planning documents

5. Map Layer Obfuscation

- Official map registries including USGS, BLM, and county survey offices layered newer maps over older tribal holdings without annotation or transparency.
- Layered title histories were erased, removing:
- Tribal land patents
- Dynastic deeds
- Sun Village and Morocco, Indiana trust documents

III. GEOGRAPHIC TARGET ZONES OF ERASURE

Region	Erased Tribal Holding	Method of Theft
Sun Village, California	Al-Shams Settlement	Redlined, annexed, reclassified as unincorporated desert zone
Morocco, Indiana	Capital of tribal buffer zone	Mapped out of significance after 1851; "laid out" by surveyors to erase sovereignty
Ohio River Corridor	Ishmaelite wagon territories	Railroad grants seized overlapping tribal paths
Appalachian Foothills	Ben outposts and caravan rest points	County border realignment; burial grounds removed from maps
Eastern Seaboard (Delaware, NJ, VA)	Coastal waqf zones & merchant tribes	Absorbed into slave counties, erased from census under "Mulatto"

IV. LEGAL VIOLATIONS & TREATY BREACHES

- 1. Violation of Treaty of Peace and Friendship
 - Erased territorial claims violated protections of tribal landholders under Islamic and Moorish jurisdiction.

2. Violation of UNDRIP

- Articles 25–28: Denial of land restitution and spiritual geography access.
- Articles 26–27: No due process in redistricting or title revocation.

3. Violation of Federal Trust Obligations

- Land reclassification removed protections afforded to Indigenous trust lands.
- Administrative manipulation violated fiduciary duty to tribal sovereigns.

4. Fraudulent Jurisdictional Reassignment

• Counties and states redrew borders without consulting tribal governments, violating the principle of **Free Prior and Informed Consent (FPIC).**

V. SOVEREIGN REMEDIES AND RECLAMATION CLAIMS


- 1. Reinstatement of Historical Tribal Maps
 - The tribe hereby issues its own official historical map overlays for:
 - Sun Village
 - Morocco, Indiana
 - Midwest Waqf Corridors
 - East Coast tribal outposts
- 2. Demand for Nullification of Illegally Imposed Boundaries
 - All land boundaries drawn after 1851 without tribal treaty or consent are to be reviewed, nullified, or corrected.
- 3. Reissuance of Tribal Geocodes and District Names
 - Restoration of sacred names under the Sun Village California Tribal Government registry.
- 4. Land Back Mechanisms
 - Restitution claims shall include:
 - Return of tribal burial lands
 - Access to historical waterways
 - Legal remapping of erased infrastructure under tribal zoning codes
- 5. Reparatory Cartography
 - The Tribe shall publish forensic maps overlaying:
 - Treaty designations
 - Ancestral waqf routes
 - Erased settlements
 - Former military land confiscations

All cartographic corrections shall be issued under SVSP, Tribe Up Registry™, and international observation.
