SUN VILLAGE CALIFORNIA TRIBAL GOVERNMENT **CHARTER**

(Bani Al-Shams)

Filed Under Divine Jurisdiction — Nunc Pro Tunc, In Perpetuity

PREAMBLE

We, the sovereign descendants of covenant bloodlines, prophetic ancestry, and indigenous tribal nations — in memory of our founder **Melvin Ray Grubbs** and under the living leadership of the **Sun Village Council**, do hereby proclaim, declare, and constitute this Tribal Government Charter of **Sun Village California**, known to the nations as **Bani Al-Shams**.

This Charter shall form the living spine of our government — grounded in tribal, divine, and natural law — and enforced through both our *sacred inheritance* and *legal dominion* under the Universal Reservation of Rights (URR®™).

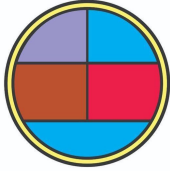
ARTICLE I: NAME AND AUTHORITY

1. The name of this sovereign tribal government shall be:
Sun Village California Tribal Government (Bani Al-Shams)
2. This government derives its authority from:
 - **Covenant bloodline and prophetic descent**
 - **The land purchased in fee simple by Founder Melvin Ray Grubbs**
 - **Rights secured under the URR®™**
 - **The divine law of Torah, Gospel, and Qur'an**
 - **Indigenous title recognized under international law and custom**

ARTICLE II: STRUCTURE OF GOVERNMENT

The Government of Sun Village shall be composed of the following organs:

- **Tribal Council** – legislative and communal representation body
- **Sovereign Press (SVSP)** – executive publishing and legal enforcement arm
- **Judiciary Council** – tribal adjudication and arbitration body
- **Tribal Police & Enforcement** – security and law enforcement under Charter IV
- **Economic Division** – managing trusts, commerce, and tribal enterprises

Each organ shall operate under the authority of this Charter and its respective sub-charters.

ARTICLE III: TERRITORIAL CLAIMS AND SOVEREIGNTY

1. Sun Village California claims **sovereign jurisdiction** over:

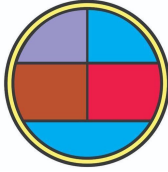
- All tribal land held in fee simple by the descendants of Melvin Ray Grubbs
- Any lands declared under URR®™ as tribal domain
- Any property held by recognized trusts and tribal arms

2. No federal, state, county, or municipal agency may interfere with tribal land, records, declarations, or jurisdiction without violating international law and URR protections.

ARTICLE IV: MEMBERSHIP AND CITIZENSHIP

1. Tribal citizenship shall be granted to:
 - All descendants of recognized bloodlines and tribal elders
 - Individuals registered under the **Sun Village National Registry** or **Tribe Up Registry™**
2. All citizens are subject to the protections, duties, and rights of this Charter.

ARTICLE V: GOVERNANCE PRINCIPLES

1. All governance shall proceed under the principles of:
 - **Divine Justice**
 - **Covenant Sovereignty**
 - **Bloodline Inheritance**
 - **Economic Restoration**
 - **Cultural Redemption**
2. The government shall maintain absolute non-subordination to any foreign power unless by treaty.

ARTICLE VI: DECLARATION OF IMMUNITY

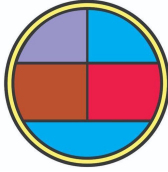
All officials, elders, and signatories acting under the authority of this Charter shall be protected from:

- Civil liability under foreign statutes
- Prosecution by unauthorized jurisdictions
- Interference by any public or private entity acting outside recognized treaties

This immunity is enforceable by URR, tribal protocol, and international declaration.

ARTICLE VII: AMENDMENT AND PRESERVATION

1. This Charter may only be amended by:
 - Full vote of the Tribal Council
 - Affirmation by sovereign signatory elders
 - Recording under SVSP with new QR sealing and digital signature
 2. All amendments shall be made a matter of public record under SVSP.

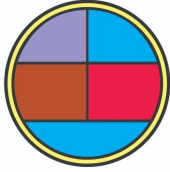
