House Buhijji Sovereign Postal Authority

Under the full authority of the Sovereign Estate, governed by the Postal Charter and the Postage Stamp Act, this document certifies the lawful creation and issuance of the first official sovereign stamp of House Buhijji for the year **2026**.

- Stamp Title: * The Dingir Star of Sovereignty
- Year of Issue: 2026
- **Jurisdiction:** Sovereign Estate of House Buhijji
- Series: Year One of the Sovereign Cycle (2026–2036)
- Theme: Per Divinum Jus Sanguinis
- Design Description:

The stamp features an eight-pointed celestial starburst (Dingir emblem) in white over a crimson red background, surrounded by the circular inscription **PER DIVINUM JUS SANGUNIS**—the motto of House Buhijji and binding covenant of its hereditary claim to divine postal authority. Below the seal, in bold white letters, the words **POSTAGE PAID** confirm its legal usage and sovereign standing.

LEGAL STANDING

This stamp is legally recognized as:

- 1. A Valid Postal Instrument
 Authorizing postage and delivery through the House Buhijji Postal System and recognized tribal/sovereign exchange networks.
- 2. A Sovereign Fiscal Token

 Denoting prepaid value under sovereign authority, akin to a certificate of credit or bearer instrument within the economic jurisdiction of the estate.
- 3. A Diplomatic Emblem
 Protected under Article V of the Postage Stamp Act, and recognized as a **symbol of mail immunity** and treaty-based protection under the UPU and relevant indigenous and international law.
