URR®™ GLOBAL FEE SCHEDULE

Issued Under Tribal, Federal, International, Admiralty, and Divine Jurisdiction

I, **Mohamed-Hasan :Buhijji, URR®™**, a living man, Sheik, Beneficiary, and Minister of covenant bloodline, together with co-Plaintiffs and dynastic trusts, do hereby establish this **Global Fee Schedule** as binding upon all officers, agents, trustees, corporations, agencies, and successors — public and private, domestic and foreign.

This Schedule enforces remedies under the **Divine Revelation of the Universal Reservation of Rights Charter (URR®™)** and attaches personally and corporately to every violator, nunc pro tunc, in perpetuity.

1. General Principles

- All rights are reserved without prejudice (UCC 1-308, URR®™).
- Any violation of Plaintiffs' rights, trusts, or bloodline inheritance triggers immediate liability under this Fee Schedule.
- Fees accrue both on the **public side** (commercial/statutory) and the **private side** (equity, trust, dynastic, divine).
- Fees compound **daily** until remedy is delivered.

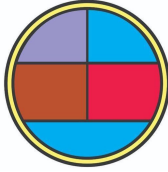
2. Public Side Penalties (Commercial / Statutory)

- **\$1,000,000 per day** — Unlawful foreclosure, repossession, seizure of instruments or property.
- **\$1,000,000 per violation** — Fraudulent misrepresentation, concealment, or failure to disclose material facts.
- **\$1,500,000 per violation** — Civil rights deprivation under color of law (18 U.S.C. §§241–242).
- **\$2,000,000 per violation** — Denial of tribal sovereignty, Indigenous rights, or Moorish Aboriginal status.
- **\$2,500,000 per violation** — Desecration, obstruction, or unauthorized use of Plaintiffs' flags or seals.
- **\$5,000,000 per violation** — Presumption of citizenship, fraudulent conversion of nationality, or denial of Indigenous American National status.
- **\$10,000,000 per violation** — Interference with ministerial or diplomatic authority.

3. Private Side Penalties (Trust / Equity / Divine)

- **\$1,000,000,000 per day** — Fraudulent foreclosure, wrongful repossession, or unlawful conversion of tribal property.
- **\$1,000,000,000 per violation** — Breach of fiduciary duty by trustees, lenders, or officers.
- **\$2,000,000,000 per violation** — Denial of covenant inheritance or trespass upon tribal territory.
- **2,500,000,000 per violation** — Tampering with recorded documents or obstructing publication of URR®™.
- **\$5,000,000,000 per violation** — Presumption of corporate citizenship, nationality fraud, or racial misclassification.
- **\$10,000,000,000 per violation** — Crimes against humanity: unlawful detention, systemic deprivation of rights, or international treaty violations.

4. Triggering Events

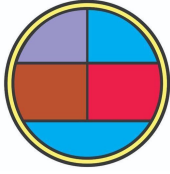
Fees automatically apply upon:

- Any act of trespass, fraud, or obstruction.
- Any attempt to convert status, property, or instruments.
- Any refusal, delay, or hindrance in executing lawful remedies (reconveyance, satisfaction, discharge).
- Any desecration of dynastic, tribal, or ministerial seals and insignia.

5. Accrual & Enforcement

- Fees accrue **daily**, compounding until full restitution.
- All debts are secured by lien upon **public and private estates** of violators.
- Liens extend to corporate charters, bonds, insurance policies, and public offices.
- Fees are enforceable in:
- **Federal courts** (28 U.S.C. §§1331, 1333).
- **State courts** (Cal. Civ. Code §§3300–3333).
- **Tribal forums** (Sun Village California Tribal Government).
- International tribunals (ICC, UNHRC, OAS).
- **Divine jurisdiction** (covenant law, Torah, Bible, Qur'an).
