*** HOUSE BUHIJJI**

TREATY OF POSTAL SOVEREIGNTY

By Order of the High Commissioner, Postmaster General, and Sovereign of the House

ARTICLE I – TITLE AND AUTHORITY

This instrument shall be known as the * **Treaty of Postal Sovereignty** of House Buhijji. It is issued under the full sovereign right of the dynastic estate of House Buhijji, by **His Imperial and Royal Highness Mohamed-Hasan :Buhijji**, High Commissioner, Grand Chancellor, Postmaster General, and Lord of the Sovereign Estate, operating under divine, tribal, and international law, including the **Universal Postal Union (UPU)** treaty framework and all natural rights established by indigenous law, diplomatic custom, and divinum jus sanguinis.

ARTICLE II – DECLARATION OF POSTAL SOVEREIGNTY

The House of Buhijji formally declares itself a **sovereign postal authority**, possessing:

- **Full legal right** to issue, circulate, and authenticate postage, seals, and communications;
- **Exclusive authority** to appoint postmasters, issue postal instruments, and determine routing protocols;
- **Jurisdictional independence** over all mail originating from, addressed to, or carried under the seal and stamps of the House;
- **Recognition of all mail** as protected communication under sovereign and international postal law, subject to the rights of inviolability, neutrality, and transmission security.

ARTICLE III – LEGAL FRAMEWORK

This Treaty operates pursuant to and is protected under the following bodies of law:

1. **The UPU Constitution and Acts** (Berne Treaty, 1874 and subsequent reforms);
2. **The Vienna Convention on Diplomatic Relations (1961)**, Articles 27–28 on diplomatic bag and communication protections;
3. United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), especially Articles 5, 8, 18, 20, 33, and 36;
4. **Law Merchant and Customary Postal Practice**, as established by sovereign issuers (e.g., Vatican, Morocco, Tannu Tuva, Princely States, etc.);
5. **House Buhijji’s Royal Authority** as a dynastic sovereign entity with ancestral and tribal jurisdiction.

ARTICLE IV – STAMPS AND POSTAL INSTRUMENTS

All official stamps, seals, postal notes, and instruments issued by House Buhijji:

- Shall be issued annually, beginning with the Dingir Cycle (2026–2036);
- Shall carry **dynastic insignia**, legal QR encoding, and fiscal signature;
- Shall be recognized as legally valid postal and fiscal tokens of the sovereign estate;
- Shall be protected under forgery and interference statutes per international norms.

ARTICLE V – APPOINTMENTS AND REGIONAL AUTHORITIES

The House of Buhijji reserves the sole right to:

- Appoint **Regional Postmasters** in the thirteen global cultural regions;
- Establish **Postal Missions** and **Diplomatic Corridors** on tribal, neutral, or international lands;
- Recognize, revoke, or realign postal authorities under its sovereign command;
- Maintain an official **Postal Registry** of all stamps, appointments, and routes.

Confirmed to date:

- **Postmaster of North America:** *Jannah Abdulrahman Al-Failakawi*, appointed in 2019 (recognized nunc pro tunc).

ARTICLE VI – RIGHTS AND PROTECTIONS

1. All House Buhijji postal mail, bearing its stamp and seal, shall be:
 - Considered diplomatic and sovereign correspondence;
 - **Inviolable**, not to be searched, seized, delayed, or withheld by third parties;
 - Protected under postal secrecy, inviolability, and sovereign immunity.
2. Any obstruction or interference shall be treated as an act of **postal trespass**, subject to redress under sovereign and international law.

ARTICLE VII – IMPLEMENTATION AND ENFORCEMENT

This Treaty shall take immediate effect upon publication, and shall be:

- Archived under the **Strategic Vault** of House Buhijji;
- Issued in PDF, hardcopy, and blockchain-protected formats;
- Registered through internal government seals and, if required, presented to international bodies for acknowledgement.
