## I. PREAMBLE AND PURPOSE

**Jennah Abdulrahman Al-Failakawi** is lawfully appointed and has since 2019 held lawful standing as **Postmaster of North America**, one of the thirteen global postal jurisdictions under the House Buhijji Sovereign Estate.

This appointment was made under the sovereign capacity and lawful title of the undersigned, in full compliance with:

- The Universal Postal Union (UPU) Treaty Framework
- Tribal and Customary Law
- The URR®™ Global Framework
- Ministerial and Dynastic Sovereign Law
- The Seal of the Chancellery of the Grand Chancellor

### II. GRANT OF POSTAL POWERS AND STANDING

The aforementioned Postmaster is hereby endowed with full powers, protections, and responsibilities inherent in the office, including but not limited to:

- 1. **Sovereign Authority** to operate and maintain postal stations across North America under the seal of House Buhijji.
- 2. **Jurisdictional Recognition** as a diplomatic and sovereign operator under the 2019 Postal Charter of the House.
- 3. **Custody of Seals, Marks, and Stamps** for lawful correspondence under tribal law, international protocol, and treaty protections.
- 4. **Ministerial Oversight** of mail routes, parcel sovereignty, diplomatic pouch designation, and sacred scroll custodianship.
- 5. **Right of Enforcement** through the Court and Chancellery of the House of Buhijji for matters of infringement, interception, or impersonation.

#### III. DECLARATION OF LEGITIMACY AND RECITAL OF RECORD

Let it be known to all present and future agencies, courts, governments, councils, tribes, consulates, customs houses, and carriers that:

This Commission is lawful, binding, irrevocable, and sovereign in nature.

This declaration stands as both a historical and legal notice that Jennah Abdulrahman Al-Failakawi was duly appointed **prior to any affiliation or association with other tribal or civic jurisdictions**, and remains under the sole ministerial supervision of His Imperial Royal Highness, Grand Chancellor and Postmaster General of House Buhijji.

This Letter of Commission shall remain in force until such time as it is lawfully revoked or superseded by written decree under the Grand Seal of the House.
