





PROCLAMATION OF THE GREAT SEAL OF THE BEN ISHMAEL NATION

Issued Under the Authority of ***** House Buhijji

In Complement to the Charter of June 23rd, 2025

Filed with the Sun Village Sovereign Press (SVSP)

Dated: June 23, 2025

I. PREAMBLE

Let it be declared before all courts of man and the annals of heaven:

We, the lawful descendants of **Ishmael**, son of Abraham — exiled across oceans, renamed, reclassified, sterilized, and systemically erased — do now reclaim our sovereign voice and tribal insignia. Our blood was scattered, our legacy buried under colonial pseudoscience, but our covenant with truth remains unbroken.

By law, by lineage, and by living memory, we now proclaim and restore the rightful seal of our nation forged in exile, anchored in divine inheritance.

II. DECLARATION OF ESTABLISHMENT

By divine blood right (jus sanguinis), verified genealogical record, and tribal command under House Buhijji, we hereby **establish** and **proclaim** the:

Said seal shall serve as the binding national emblem of the Ben Ishmael people. It is authorized for use across all legal, diplomatic, tribal, historical, governmental, and ceremonial actions undertaken by or on behalf of this sovereign nation.















III. DESCRIPTION AND SYMBOLISM OF THE SEAL

The **Great Seal of the Ben Ishmael Nation** contains the following sacred and historical elements:

- A **five-pointed golden star** nested within a **crescent**, affirming Semitic ancestry, divine covenant, and rightful inheritance through **Ishmael**, progenitor of the Arab peoples.
- A pair of **crossed scimitars** at the base, representing the martial right of tribal defense, and the ancestral lineage through **Tamim**, **Kaab**, and **Sulayim** warrior houses of the Arabian interior.
- An **open sacred book**, representing the reconstitution of erased records, the literacy of a persecuted nation, and the survival of divine law beneath the ashes of institutional denial.
- **Eight red and black arrows** pointed outward from the center, marking the **eight directions of exile**, dispersion, and tribal reassembly north, south, east, west, and the intercardinal paths of forced migration and resistance.
- A background featuring **the African continent**, from which the original Ishmaelite and Moorish migrations emanated toward the Americas.
 - A crimson border bearing the golden inscription:

"GREAT SEAL OF BEN ISHMAEL NATION - FOUNDED IN EXILE, RESTORED BY LAW"

- A golden ribbon below reading:
- "Per Divinum Jus Sanguinis" (By Divine Right of Blood)

with the restored tribal timeline:

"1785–1905 Migration • Restored 2025"

Every visual element in this seal is legally and spiritually anchored in the genetic, tribal, and historical record — both as a defense and as a declaration.

IV. JURISDICTION AND AUTHORITY

This Seal holds full jurisdiction as the **sovereign insignia** of the **Ben Ishmael Nation**, recognized under the authority of:

- **₩ House Buhijji**, as genealogical sovereign
- The **Ben Ishmael Nation**, as a reconstituted tribal polity

Its authority extends across all documents, proclamations, filings, claims, and instruments executed by any branch of the Ben Ishmael national government or its diplomatic extensions. Unauthorized reproduction, desecration, or misappropriation of this seal constitutes a violation of tribal and international law.

V. CUSTODIANSHIP AND USE

The **custody and defense** of this seal are entrusted to:

His Imperial and Royal Highness Prince Sheikh Mohamed-Hasan :Buhijji Sovereign of the Ben Ishmael Nation Grand Chancellor of House Buhijji Postmaster General of the Tribal Estate Minister of Divine Providence Chief Executor and Keeper of the Covenant

All documents bearing this seal are to be authenticated through QR-coded registration, tribal archive indexing, and digital stamp certification under the SVSP.

VI. REGISTRATION AND PERMANENT RECORD

This proclamation is:

- Entered into the permanent archive of the Sun Village Sovereign Press (SVSP)
- Appended to the ***** House Buhijji Charter, dated June 23rd, 2025
- Cross-referenced with the **Ben Ishmael Tribal Declaration**, its eleven appendices, and all forthcoming instruments of sovereign expression

This proclamation is issued and sealed on this day: 23rd of June 2025
