BEN ISHMAEL CHARTER AND RESTORATION ORDER

Royal Charter, Tribal Decree, and Dynastic Reaffirmation of the Ben Ishmael Tribe
By His Imperial and Royal Highness, Sheikh Mohamed-Hasan :Buhijji, High Commissioner, Grand
Chancellor, and Postmaster General of House Buhijji

I. PREAMBLE

We, the living sovereign descendants of the Autochthonous, Indigenous, and Dynastic Houses of the East and the West, do now issue this binding and eternal Charter and Restoration Order, for the formal **reinstatement, reaffirmation, and reconstitution** of the *Ben Ishmael Tribe* as a sovereign tribal nation under the protection, recognition, and legal jurisdiction of the  **House of Buhijji**, and its governing arms, including **The Chancellery, The Court, and the Committee on Tribal Affairs**.

This document is issued under the full lawful and divine authority of the undersigned sovereign, by right of blood (*jus sanguinis*), by right of land (*jus terrae*), and by sacred historical memory—secured in both temporal and spiritual law—and carried in the DNA, oral traditions, written records, and forensic genealogical trail of the Ben Ishmael people.

II. PURPOSE AND INTENT

This charter serves to:

1. **Formally restore the Ben Ishmael Tribe** as a lawful tribal nation under international, tribal, indigenous, ecclesiastical, and dynastic law.

2. **Reverse and nullify** all acts of denationalization, racial erasure, criminal branding, forced migration, and genealogical suppression perpetrated by local, state, federal, and colonial entities over the past 150 years.
3. **Reassert the lineage, contributions, and cultural sovereignty** of the Ben Ishmael people across North America and the global diaspora.
4. **Place the tribe under sovereign protection** of House Buhijji and affiliate institutions for purposes of recognition, legal defense, land reclamation, international representation, and historical record correction.

III. HISTORICAL FOUNDATIONS

The **Ben Ishmael Tribe**, historically known through oral, religious, and forensic accounts, traces its descent through **Moorish, Islamic, Hebrew, and African-Indigenous** channels, with presence recorded in:

- **Indiana, Kentucky, and Illinois** during the 18th and 19th centuries.
- Migration routes that followed underground freedom networks, tribal dispersal patterns, and Islamic missionary pathways.
- Federal, religious, and sociological records—some of which deliberately **classified the tribe as “degenerate,” “White Trash,” or “criminal vagrants”** as part of systemic eugenic and denationalization programs.
- Oral traditions that preserve **Islamic religious practices, genealogical naming conventions, and social organization** independent of U.S. constructs.

This restoration recognizes that the Ben Ishmael Tribe was never lawfully extinguished, only **politically reclassified** and administratively **erased**.

IV. LINEAGE AND LEGAL ANCHOR

This charter confirms that the Ben Ishmael Tribe:

- Descends from **Ishmael, son of Abraham**, carrying the spiritual and tribal heritage of **Mizrahi, Maghrebi, Moorish, Arabian, and Afro-Asiatic** bloodlines.
- Possesses **sovereign right of re-constitution** under the laws of nations, including:

- United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)
- Montevideo Convention on the Rights and Duties of States (1933)
- The Convention on the Elimination of All Forms of Racial Discrimination (CERD)
- International Covenant on Civil and Political Rights (ICCPR)
- Ecclesiastical and Dynastic Law as practiced under the House of Buhijji

V. RECOGNITION AND PROTECTION

By this Charter:

- The **Ben Ishmael Tribe** is fully recognized as a **sovereign tribal body**.
- All members of the tribe are entitled to **diplomatic protection, land reclamation, and identity reclassification** through the **Sun Village Tribal Government, the Sun Village Trust, and the sovereign Chancellery of House Buhijji**.
- A **National Tribal Registry** shall be maintained under **SVSP – Sun Village Sovereign Press**, with QR-coded credentials and DNA confirmation.
- The **ancestral dignity, divine purpose, and cultural mission** of the Ben Ishmael shall be reactivated and preserved in perpetuity.

VI. EXECUTIVE ORDERS

In execution of this Charter:

1. A **Ben Ishmael Restoration Committee** shall be established to record oral histories, conduct genealogical confirmations, and secure tribal affiliation for all rightful heirs.
2. The **Committee on Tribal Affairs** shall publish historical and legal documentation correcting all defamatory or fabricated narratives imposed on the Ben Ishmael people by outside powers.
3. A **Digital Archive** and Sovereign Historical Repository shall be hosted under the official domain of House Buhijji for global reference and scholarly protection.
4. This Charter shall be **recorded under international notice** via blockchain, timestamp, and sovereign seal, and shall be made available to all Indigenous, Islamic, African-American, and International Human Rights institutions for acknowledgement and collaboration.

VII. PERMANENT STATUS

This charter shall never expire, and is **hereby sealed permanently** into the dynastic, legal, and tribal records of:

- ✱ House Buhijji
- Sun Village California Tribal Government (Bani al-Shams)
- Sun Village Sovereign Press (SVSP)
- The Court and Chancellery of the Grand Estate
- All Committees, Archives, and Future Successors-in-Title

Any attempt to nullify, suppress, or discredit this restoration is declared **void ab initio**, and shall trigger full invocation of protective and corrective measures under divine, tribal, and international law.
