This Notice formally establishes **sovereign, tribal jurisdiction** over all lands, properties, and physical or digital territories governed or occupied by:

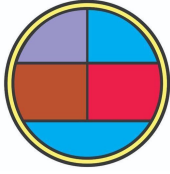
- The **House of Al-Buhijji**

II. NO TRESPASS CLAUSE

NO TRESPASS is declared against:

- Government agents or officers acting under color of law
- Debt collectors, inspectors, appraisers, or third-party contractors
- Foreign actors, military personnel, or agents of any unrecognized jurisdiction
- Individuals not explicitly invited or contracted under tribal covenant

Entry upon this land, physical or digital, without explicit tribal consent constitutes:

- **Trespass**
- **Piracy**
- **Invasion of a sovereign estate**
- **Violation of international law and private trust territory**

III. ENFORCEMENT REMEDIES

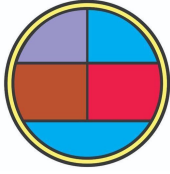
All trespass, interference, or attempts to assert jurisdiction are subject to:

- **Private-Side Enforcement** via URR®™, Tribal Law, Ecclesiastical Jurisdiction, and International Covenant

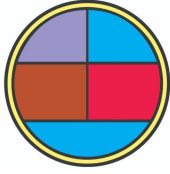
