Issued under the Postal Charter of 2019

**IN THE NAME OF THE MOST HIGH, BY THE AUTHORITY OF THE HIGH
COMMISSIONER, POSTMASTER GENERAL, AND SOVEREIGN OF HOUSE BUHIJJI,**

Let it be hereby known and eternally recorded in the sovereign registers of House Buhijji and its international stations, that:

is formally and lawfully appointed as

POSTMASTER OF NORTH AMERICA

Acting in full capacity under the Postal Charter of 2019,
with all rights, duties, immunities, protections, and privileges appertaining thereto.

This appointment is vested by the De Facto Sovereign Postal Authority of House Buhijji, under the rights guaranteed by:

- The Universal Postal Union (UPU) Treaty,
- International custom and tribal law,
- House Buhijji sovereign instruments and charters,
- And the foundational authority of the  *Chancellery of the Sovereign Estate*.

Authorities Granted:

1. **To administer, oversee, and establish sovereign postal stations** within the geographical, cultural, and ancestral boundaries of **North America**;
2. To transmit diplomatic and tribal correspondence sealed by sovereign authority;
3. **To enforce sovereign postal law and immunity** in accordance with treaties, tribal protocols, and the international rights of non-domestic nationals;
4. **To affix the sovereign seal of House Buhijji** upon documents transmitted through said post;
5. To receive, dispatch, and protect diplomatic cargo, declarations, proclamations, and registry matters;
6. **To serve as official recordkeeper and mail handler** of the Sovereign Court, Chancellery, and Committees under House Law.
