<u>APPENDIX VI - RACIAL MISCLASSIFICATION AND INSTITUTIONAL PAPER</u> GENOCIDE

Annexed to the Declaration of Restoration of the Ben-Ishmael Nation Filed under the Authority of the Sun Village California Tribal Government (Bani Al-Shams)

I. PURPOSE

This appendix establishes the **systematic racial misclassification** of Ben-Ishmaelite descendants as a central mechanism of **paper genocide**, carried out through census fraud, court manipulation, hospital records, and legislative erasure.

It documents how tribal families of **Semitic, Moorish, and Amerindian origin** were reclassified as "Negro," "Colored," "Mulatto," or "White Trash" — thereby stripping them of **sovereign protections**, **land rights, inheritance chains**, and **dynastic standing**.

It further asserts the **legal nullity** of those racial designations under international law, tribal law, and American treaty doctrine.

II. DEFINITION OF PAPER GENOCIDE

Paper Genocide is the bureaucratic erasure of a people by:

- Falsifying their racial or national identity in public records
- Destroying genealogical documentation or reclassifying lineage
- Rendering tribal affiliations unrecognized by legal institutions
- Eliminating language, religion, and naming systems from administrative usage

For the Ben-Ishmael Nation, paper genocide meant:

- Becoming legally invisible
- Losing access to treaty protections
- Being subjected to sterilization, criminalization, and land dispossession
- Being denied their own origin story

III. SYSTEMATIC RECLASSIFICATION OF BEN-ISHMAELITES

Institution	Misclassification	Effect on Ben-Ishmael Families
U.S. Census Bureau	"Negro," "Colored," "Mulatto," "White Trash"	Removed tribal designation; barred from white status
Public Health & Eugenics Boards	"Inbred," "Unfit," "Degenerate"	Forcible sterilization, mental institution commitments
County Clerks & Recorders	No tribal identifier allowed	Land deeds, marriage licenses
Public School Systems	Racial assignment by skin tone	Denied tribal language and Islamic education
State Courts & Probate	Reclassified as non-heirs	Estates seized by counties or redistributed
Social Services & Welfare Offices	Filed under Black or White categories only	Tribal entitlements erased, treated as foreign dependents

IV. LEGAL FRAUDULENCE OF RACIAL LABELING

- 1. No Statutory Definition of "Black" or "White"
 - Most racial classifications used in 19th–20th century documents were **arbitrary** and unsupported by scientific or legal criteria.
- 2. Census Designations Based on Visual Inspection
 - Field agents were instructed to classify individuals by **appearance** or **neighborhood**, not by genealogical or tribal record.
- 3. Deliberate Erasure of Semitic & Moorish Categories
 - Arabic names, Islamic affiliations, or tribal surnames were either **anglicized**, **omitted**, **or flagged** for removal.
 - State records instructed agents to treat "Arabian" or "Moorish" as **foreign**, even for U.S.-born tribal citizens.
- 4. Violation of Treaty and Indigenous Law
 - U.S. racial designations **overrode tribal sovereignty**, in direct breach of agreements like:
 - The Treaty of Peace and Friendship
 - The Articles of Confederation's tribal recognition clause
 - UNDRIP and the Law of Nations

- 5. Identity Reversal for Control
 - True Semitic tribes were **labeled as Black** to strip sovereignty.
 - In contrast, white-passing immigrants were **granted whiteness** without lineage based solely on compliance.

V. GENEALOGICAL DAMAGE & TRIBAL AMNESIA

Consequences of reclassification:

- **Loss of Trust Designation:** Tribal land held in admiralty or ancestral trust could not be inherited under racialized probate law.
- Erasure of Children's Rights: Ben-Ishmael children enrolled in tribal schools or religious madrassas were forcibly moved to "colored" institutions or white orphanages.
- **DNA Misattribution:** Today, many descendants appear "African American" in records but carry Y-DNA and mtDNA signatures of Arabian, Berber, Cherokee, or Lenape ancestry.
- **Forced Assimilation into Welfare State:** Tribal self-reliance was replaced with criminalization, dependence, and social services under false racial coding.


VI. RESTORATIVE ACTIONS AND CORRECTIONS

- 1. Nullification of Racial Classifications
 - All state-imposed racial codes applied to Ben-Ishmael families from 1790 onward are **legally and historically nullified.**
 - All descendants may formally disavow "Black", "Negro", "White", "Colored", or "Mulatto" designations in public records and issue tribal corrections.
- 2. Recognition of Ben-Ishmael as Semitic-Moorish-American
 - A distinct legal and genealogical identity is hereby restored and codified.
- 3. Right to Amend Records
 - Tribe members may request correction of:
 - Census forms
 - Birth, marriage, and death certificates
 - School and military records
 - Property deeds
 - Any historical legal document with improper racial designation

- 4. Reintegration Into Sovereign Jurisdiction
 - All misclassified persons are now recognized as tribal citizens of the **Ben-Ishmael Nation under the Sun Village California Tribal Government**, with full access to trust reinstatement, reparative action, and identity restoration.

VII. DECLARATION OF RECLASSIFICATION NULLITY

We declare that:

- Every legal act, administrative form, or institutional label applied to the Ben-Ishmael Tribe that **contradicted our Semitic, Amerindian, or Moorish identity** was **fraudulent and void ab initio**.
- These classifications were designed to **strip sovereignty**, not reflect lineage.
- We reclaim our names, blood, languages, treaties, and designations in full.
