SUN VILLAGE TRUST CHARTER

(REINSTITUTION OF THE UNIFIED TRIBAL ASSET HOLDING ENTITY)

Filed Under Divine, Tribal & Dynastic Jurisdiction — Nunc Pro Tunc, In Perpetuity

PREAMBLE

This Charter reconstitutes the **Sun Village Trust**, the original holding structure established by the Founder, **Melvin Ray Grubbs**, in the mid-20th century for the sole benefit of the **Indigenous, Moorish, and Black American residents of Sun Village, California**.

This Trust was unlawfully dissolved and erased from county, state, and federal records — resulting in **the collapse of five sovereign commercial entities** and the dispossession of tribal economic infrastructure, water rights, energy contracts, and real estate initiatives.

This Charter corrects the record and **restores the Sun Village Trust** to full legal and sovereign operation, retroactively and prospectively.

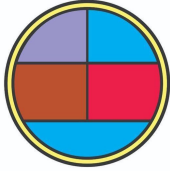
ARTICLE I: FOUNDATIONAL HISTORY

1. The Sun Village Trust was founded as the **central legal and economic repository** for the following confirmed entities:
 - **Sun Village Incorporated Land Corporation (1939)**
 - **Sun Village, Inc. (1944)**
 - **Sun Village Water Company**
 - **Sun Village Energy Company**
 - **Sun Village Improvement Company**

2. These entities were created under the direct authority of **Melvin Ray Grubbs**, a Cherokee tribal member of Moorish descent, born in **March 1900**, who held the land in **fee simple absolute**.
3. The Trust served to consolidate tribal land titles, administer infrastructure, issue land use agreements, and protect sovereignty under **private deed and covenant grant**.
4. Upon the **unauthorized dissolution** of these five corporations, the underlying **Trust corpus remained intact** as a matter of law — protected under **equitable, tribal, and divine jurisdiction**.

ARTICLE II: PURPOSE AND FUNCTIONS

The reestablished **Sun Village Trust** shall serve the following roles:

- **Title & Deed Holding Agent:**

- Holds legal title to all tribal, community, and covenant lands in Sun Village.
- Maintains equitable interest on behalf of tribal members and heirs.

- **Infrastructure Custodian:**

- Manages all physical assets, easements, water rights, energy rights, roads, and tribal facilities.

- **Tribal Beneficiary Fund:**

- Receives proceeds from settlements, court victories, or contractual enforcement to fund tribal programs, reparations, and land restoration.

- **Contract Enforcer:**

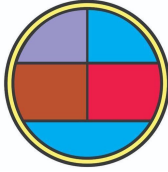
- Binds parties under original trust instruments, commercial deeds, private contracts, and equitable lien doctrines.

1. Trustee Body:

- Administered by the **Sun Village Tribal Council**, the **House of Al-Buhijji**, and recognized elder families of Sun Village.
- Founder **Melvin Ray Grubbs** is posthumously declared **Perpetual Chief Trustee Emeritus**.

2. Trust Beneficiaries:

- All current and future tribal members, recognized heirs, and descendants of land-granted Indigenous families.
- Includes **Sun Village California Tribal Government**, all subsidiary LLCs, and holders of tribal instruments.

3. Trust Protector:

- Appointed office under **SVSP** authority with power to veto foreign encroachments, fraud, or attempts to alter trust terms.

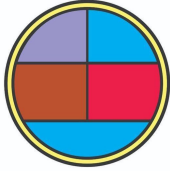
ARTICLE IV: LEGAL IMMUNITY & RECOGNITION

- **The Sun Village Trust is sovereign and non-taxable.**
- Immune from:
 - Property seizure
 - Forced registration
 - Eminent domain
 - Taxation
 - Corporate dissolution

ARTICLE V: TRUST RESTORATION & RECORD CORRECTION

 - Existing bloodline claims
 - Reconstructed tribal lineage
 - SVSP-led land audits
3. The Trust is now integrated with the **Sun Village National Registry** and the **Tribe Up Registry™**, ensuring global recognition.

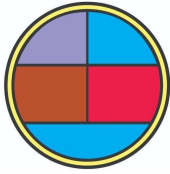
ARTICLE VI: EQUITY & ENFORCEMENT
