CHARTER OF AMEXEM

Declaration of Continental Sovereignty, Memory, and Indigenous Right
House Buhijji | High Commission of the Sovereign Estate | Enacted June 23, 2019

I. Preamble

In sacred memory of the ancestors who traversed the Red Sea, the Nile Valley, the Arabian Peninsula, and the Atlantic Ocean under divine providence, this Charter proclaims the full reactivation, restoration, and recognition of **Amexem** as the ancestral dominion of the Semitic-Moorish peoples.

This Charter is issued by:

- His Imperial and Royal Highness Sheikh Mohamed-Hasan :Buhijji,
High Commissioner, Grand Chancellor, Postmaster General, and Sovereign of the House Buhijji

Pursuant to the hereditary bloodlines, divine law, tribal standing, and international instruments of Indigenous and diplomatic rights.

II. Nature and Purpose of the Charter

1. **To declare Amexem** as the sovereign geographical and cultural dominion of the Moors and Semitic peoples—spanning the territories now known as North Africa, West Asia, and the Americas.
2. **To codify the ancient transatlantic presence** of Semitic peoples in the Americas prior to European colonization, via documented trade, travel, cultural exchange, and divine migration.

3. **To anchor the legal rights** of Indigenous Moors under House Buhijji to their historical, genetic, linguistic, and civilizational footprint on both sides of the Atlantic.
4. **To establish Amexem** as a legal zone of sovereignty, diplomatic protection, and civilizational continuity for all those descending from the noble lineages of Shem, Ham, and Japheth — especially Ishmael, Abraham, and their heirs.

III. Historical and Genetic Foundations

1. **Amexem** is the ancient name of the super-continent once comprising Africa, Arabia, and the Western Hemisphere — referenced in Islamic, Moorish, and Afro-Asiatic records.
2. The peoples of Amexem are:
 - **Semitic** (Akkadian, Canaanite, Hebrew, Arab)
 - **Afro-Asiatic** (Kushite, Egyptian, Ethiopian)
 - **Moorish** (Islamic dynasties, Maghrebi tribes, Andalusian scholars)
 - **Indigenous American** (Olmec, Washitaw, Yamassee, Arawak, Ben Ishmael)
3. Genetic confirmations under Y-DNA J1, E1b1b, and autosomal lineages affirm the shared ancestry between Moorish-Americans and Semitic-African peoples.
4. Records from Islamic travelers, Hebrew maps, and Moorish chronicles confirm transatlantic travel, commerce, and settlement long before 1492.

IV. Legal and Jurisdictional Authority

This Charter derives its standing from:

- **International Law:** UNDRIP, Montevideo Convention, Vienna Convention on Treaties
- **Treaty Law:** Treaty of Peace and Friendship (1787), recognized by Morocco and the United States
- **Moorish Law:** Teachings of Noble Drew Ali, Taj Tarik Bey, C.M. Bey, and the House of Buhijji

- **Genetic and Forensic Records:** DNA-confirmed lineages from Arabia, Africa, and the Americas
- **Divine Law:** Quranic authority, Abrahamic covenant, and Mosaic-Hammurabic codes of conduct
- **Tribal Law:** The Ben Ishmael Charter, The Court Charter, and The Chancellery's declarations

V. Declarations and Sovereign Rights

By this Charter, the House Buhijji declares the following:

1. **Amexem is a lawful and living dominion** of Indigenous peoples, whose identity cannot be erased, renamed, or reclassified by foreign empires or colonial regimes.
2. **All Moorish descendants in the Americas** are rightful heirs to this memory, including those now misclassified as "Black," "Negro," "Latino," or "African American."
3. **Moorish tribes across the Americas**, including Ben Ishmael, Washitaw, Yamassee, and others, are lawfully reactivated under this charter's protective banner.
4. Amexem is reestablished as a legal zone of cultural immunity and diplomatic standing, protected by tribal, religious, and international norms.
5. **Sovereign post stations, court forums, embassies, and tribal bodies** may be declared by the House Buhijji throughout Amexem, each governed by charters and seals.

VI. Protections and Enforcement

1. This Charter is sealed by the **High Commission of House Buhijji** and is enforceable under:
 - The Sun Village Sovereign Press (SVSP)
 - The Court of House Buhijji
 - The Tribal Oversight Council
 - International declarations and tribal registries

2. **Any attempt to defraud, deny, or diminish the sovereignty** of Amexem or its heirs is a violation of divine, tribal, and international law and shall be rebuked in all forums.

VII. Date and Standing

This Charter takes effect **retroactively to June 23, 2019**, the date of the Ben Ishmael restoration and Jennah's appointment as Postmaster of North America.

It remains in force perpetually, irrevocably, and eternally unless revoked by direct sovereign act.
