### **STRATEGIC VAULT PROCLAMATION**

Charter Declaring Sovereign Ownership, Governance, and Defense of All Dynastic Vault Holdings under House Buhijji Authority

#### **Preamble**

In the exercise of sovereign economic dominion and under divine, tribal, and dynastic mandate, this proclamation hereby establishes the Strategic Vault System of the House of Buhijji as an immutable, lawfully governed treasury of physical and digital assets under full protective jurisdiction.

The vault system serves as the sacred container of dynastic wealth, tribal inheritance, sacrosanct metals, sovereign reserves, and digital representations thereof. This includes real-world assets (gold, silver, currencies, instruments), crypto-collateralized reserves, and sacred heirlooms under multi-jurisdictional protections.

#### **Article I – Definition and Scope**

1. The Strategic Vault is defined as the collective sum of:
  - Physical vaults (fortified locations, banks, estates)

- Digital vaults (hardware, blockchain, cold storage)
  - Diplomatic pouches and mobile sovereign containers
2. Its purpose includes:
- Asset protection
  - Diplomatic handling of wealth
  - Generational succession planning
  - Economic issuance of tokens, currencies, and bonds
3. It is the legal treasury of:
- House Buhijji
  - Sun Village Trust
  - MHM Holdings
  - All affiliated family trusts

## Article II – Classification of Contents

1. Tier I – Sovereign Reserves:
  - Gold, silver, and platinum bars and coins
  - Minted Dinars and Sterling units (per Currency Charter)
2. Tier II – Sacred Assets:
  - Tribal heirlooms, ceremonial seals, dynastic tokens
  - Diplomatic pouches, regalia, archives
3. Tier III – Strategic Instruments:
  - Cryptocurrency private keys
  - Tokenized bond reserves
  - Diplomatic documents, codes, archives, and credentials
4. Tier IV – Intangible Assets:
  - Intellectual property
  - Books, charters, and sacred texts
  - Legal documents bearing sovereign seal

### **Article III – Custody and Control**

1. The Vault is maintained and controlled solely by:
  - The Sovereign or direct appointees by commission
  - SVMB (Sun Village Mint & Bank)
  - Postmasters or Chancellery-designated Vault Keepers
2. All assets must be:
  - Registered
  - Digitally hashed
  - QR or serial tagged
  - Protected under non-repudiation protocol
3. No foreign jurisdiction, person, state, or agency may:
  - Lay claim
  - Freeze
  - Tax
  - Confiscate
  - Digitally interfere
 without triggering economic aggression under URR Law

### **Article IV – Movement and Transport**

1. All Vault-related movements are classified as:
  - Diplomatic pouch transit
  - Protected convoy
  - Private carrier with international lawful exemption
2. Transit is governed by:
  - UPU Postal Immunity
  - Geneva Protocols on Diplomatic Bags
  - Tribal and dynastic right to sacred object movement
3. Any interference constitutes:
  - Breach of international law
  - Violation of sovereign immunity
  - Act of war under tribal law and URR

### **Article V – Succession, Transfer, and Redemption**

1. Vault ownership and stewardship follow:
  - House Buhijji Dynastic Succession Line
  - Instructions sealed under The Will of the House
  - Redemption protocols tied to biometric + cryptographic ID
2. Transfer may only occur:
  - Under royal decree
  - By official registry notarized with seal
  - Through secured blockchain protocol or Chancellery act
3. Unauthorized access or usage is subject to:
  - Tribunal under SVSP Court
  - Sovereign penalties including asset stripping and exile

### **Article VI – Status of the Vault**

1. The Strategic Vault holds the status of:
  - Sacred Sovereign Space
  - Neutral Territory under Amexem Law
  - Inviolable Economic Sanctum
2. Under the Flag and Seal of House Buhijji, the Vault enjoys:
  - Full extraterritorial immunity
  - UPU-postal chain recognition
  - Diplomatic transit shielding
3. Cybernetic Vaults are governed by:
  - SHA encryption
  - Blockchain immutability
  - Sovereign cyber-treaties (to be codified under Digital Treaty of Amexem)

This Proclamation shall be published, sealed, timestamped, and inscribed into the Dynastic Ledger of the House and enforced across all realms in perpetuity.
