APPENDIX III - RACIAL RECLASSIFICATION LEDGER

Annexed to the Declaration of Restoration of the Ben-Ishmael Nation Filed under the Authority of the Sun Village California Tribal Government (Bani Al-Shams)

I. PURPOSE

This appendix serves as a **forensic registry** and **legal indictment** documenting the systematic reclassification of the Ben-Ishmael Tribe and affiliated families from their rightful designations as *tribal*, *Semitic*, *Moorish*, *and Indigenous peoples* into state-imposed racial categories including:

- "Black"
- "Colored"
- "Negro"
- "White Trash"
- "Inbred"
- "Gypsy"
- "Mulatto"
- "Unknown"

The purpose of this ledger is to expose the deliberate **paper genocide** committed through census fraud, court rulings, immigration law, and bureaucratic reclassification.

II. HISTORICAL CONTEXT

From the 18th to 20th centuries, the United States employed legal and bureaucratic tools to forcibly dissolve tribal identities that resisted assimilation. The Ben-Ishmael people, already recognized as:

- Mohammedan
- Free Tribal Persons
- White by Sovereign Class (treaty-defined)
- Amerindian of Semitic-Moorish stock

... were stripped of their original classifications and forced under new racial codes invented for the purpose of dispossession.

Examples of Tribal Classifications Erased:

Original Classification (Pre-1850)	Reassigned Classification (Post-1850–1930)
White (Moorish Treaty Subject)	Colored, Negro, or "Inbred"
Amerindian, Ben-Ishmael, Tribal	Mulatto or Unknown
Semitic Mohammedan	Black or Muslim-African
Asiatic-Arab	Other (Non-White Alien or Gypsy)
White Free Person (Treaty Holder)	Vagrant, Degenerate, White Trash

III. MECHANISMS OF RECLASSIFICATION

1. Census Engineering

- Between 1870 and 1940, census enumerators were instructed to classify:
- All non-European tribal peoples as *Negro* or *Colored*
- All Moorish-descended families as White Trash or Gypsy
- All "Mohammedans" as foreign-born or alien non-citizen
- Birthplaces were falsified, ancestry ignored, and religious identity weaponized

2. Vital Records Fraud

- Birth, death, and marriage records were altered by:
- Redacting tribal affiliations
- Assigning "Negro" to Moorish-Arab lineages
- Assigning "White" only to land-assimilated settler families
- Tribal surnames like Ishmael, Mahomet, Hamid, and Zuwāb were forcibly renamed


3. School and Institutional Erasure

- Tribal children were removed from family homes and classified as:
- Degenerate wards
- Colored reform subjects
- Mixed-blood delinquents
- Islamic and Amerindian instruction was criminalized or erased

4. Military Classification Manipulation

- Zouave and Ben-Ishmaelite veterans were listed as:
- Negro Troops
- Colored Infantry
- Indeterminate Origin
- Service records were scrubbed of tribal names and reorganized under settler-controlled units

5. Property and Legal Status Degradation

- Tribal landowners were reclassified to void inheritance claims
- Wills and trust documents were invalidated based on "race" redefinitions
- State courts ruled that "Mohammedan" was equivalent to *non-white alien*, nullifying treaty privileges

IV. LEGAL CONSEQUENCES

The reclassification of the Ben-Ishmael Nation constitutes:

- Fraudulent Mislabeling under Treaty Law
- **Constructive Genocide** under the 1948 UN Genocide Convention
- Violation of the URR®™ Global Fee Schedule (GFS)
- Destruction of Tribal Trust Capacity and hereditary titles
- Breach of Naturalization Protections, as original inhabitants were never immigrants

V. RECLAMATION CLAIMS


The Ben-Ishmael Nation demands:

 - Federal census rolls
 - Tribal court jurisdictions
 - Immigration and naturalization records
 - Genealogical repositories
- 2. Nullification of all Forced Reclassifications, including:
 - Racial misnomering in court filings
 - Genetic misclassification by state eugenic boards

- Religious-based expulsion or foreign alien assignment
- 3. Right of Correction & Restoration:
 - Authority to issue corrected identity documents
 - Enforcement of hereditary names, lineages, and titles
 - Recognition of sovereign white/Moorish status under original treaties

VI. FORENSIC EVIDENCE TO BE SUBMITTED

- Census pages with altered racial entries (e.g., families reclassified over decades)
- Court rulings using racial pseudoscience to deny land or child custody
- Eugenic sterilization orders citing "degeneracy" based on tribal descent
- Draft cards and military registrations stripped of original tribal affiliations
- Interviews and oral histories confirming original tribal status and later "Negro" designation
