APPENDIX IX – THE INVERSION OF WHITENESS AND LEGAL RECLASSIFICATION OF THE BEN-ISHMAEL TRIBE

Annexed to the Declaration of Restoration of the Ben-Ishmael Nation
Filed under the Authority of the Sun Village California Tribal Government (Bani Al-Shams)

I. PURPOSE

This appendix documents the **systematic racial inversion** of the Ben-Ishmael Tribe — from **sovereign white tribal status** under treaty and birthright to **forcibly imposed “non-white” classification** under U.S. racial codes, census fraud, and legal manipulation. It reveals how sovereign tribes like the Ben-Ishmael were **stripped of identity, trust capacity, and treaty status**, then assigned racial categories designed to delegitimize their claims and erase their governance.

We expose this legal inversion not merely as racial injustice, but as a **strategic obliteration of political status and hereditary entitlement**.

II. THE ORIGINAL STATUS OF THE BEN-ISHMAEL TRIBE

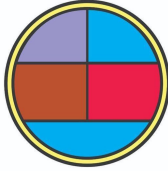
- The Ben-Ishmael Nation were:
 - **Free tribal nationals** under Indigenous law and dynastic succession
 - **Sovereign white entities** under treaty jurisprudence
 - **Islamic and Semitic communities** protected by the Treaty of Peace and Friendship
 - **Recognized sovereigns** under early American definitions of “white” as legal status, not phenotype
- “White” originally meant:
 - Not enslaved
 - Landholding
 - Sovereign or non-subjugated
 - Operating within treaty or charter

Whiteness was a political trust class, not a skin color.

III. INVERSION THROUGH LEGAL FRAUD

1. Naturalization Act of 1790

- Restricted citizenship to “free white persons”
- Used to **grant whiteness** to European migrants (servants, criminals)
- Used to **exclude sovereign tribal Moors and Semites**, reclassifying them as foreign or “Black” despite prior land rights

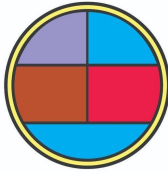
2. Racial Codification of the 19th Century

- Beginning mid-1800s, the federal government redefined “white” to mean **European descent only**, despite:
 - Tribal sovereignty
 - Birthright treaties
 - Light phenotype and Semitic features
 - Ben-Ishmaelite families were:
 - Reclassified as “Colored,” “Mulatto,” or “Negro”
 - Removed from “White” land registries
 - Assigned census codes without their knowledge or consent

3. Eugenics Movement in Indiana

- Indiana’s 1907 sterilization laws targeted the Ben-Ishmael Tribe as “degenerate” white trash
- Tribespeople were:
 - Denied marriages
 - Forcibly institutionalized
 - Declared “mentally defective” to justify sterilization
 - Assigned false racial origins to sever land claims

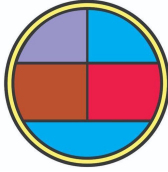
IV. EVIDENCE OF TARGETED INVERSION

Original Status	Imposed Status	Mechanism of Inversion
Sovereign tribal Moors (Semitic & Amerindian)	Negro / Colored	Census codes, court orders
Treated “white” under Peace and Friendship	Alien non-citizen	Naturalization exclusion
Wards of tribal courts & dynastic trusts	State wards / vagrants	Court guardianship manipulation
Landholders	Nomads / trespassers	Redistricting, tax fraud
Tribal military veterans (Zouaves)	Vagrants / criminal class	Pension denial, mislabeling of service records

V. MODERN CONSEQUENCES OF RECLASSIFICATION

- Loss of Trust and Treaty Standing:
 - Once reclassified, Ben-Ishmaelite bloodlines were **denied land trust access**, tribal enrollment, and hereditary leadership rights
 - Educational & Institutional Erasure:
 - Tribal schools and religious centers rebranded as “negro” institutions or demolished
 - Census-Fueled Extermination:
 - Over five generations erased through **paper genocide**
 - Disinheritance by Design:
 - Descendants labeled as “Black” or “Other” were denied:
 - Probate inheritance
 - Mineral/water rights
 - Homesteading trust claims
 - Retroactive recognition as founders or veterans

VI. SOVEREIGN REMEDIES AND REVERSALS

1. Legal Reinstatement of Original White Status

- The Ben-Ishmael Tribe hereby asserts:
- Tribal whiteness as original sovereign class, not settler race
- White status by treaty, trust, and hereditary governance

2. Nullification of All Imposed Racial Codings

- All labels of “Black,” “Negro,” “Colored,” and “Mulatto” forcibly assigned to Ben-Ishmaelite descendants are null and void

3. Reclassification Under SVSP and URR

- The Sun Village Sovereign Press and Tribe Up Registry™ shall:
- Issue identity restoration papers
- Affirm original trust status
- Classify tribal members as Sovereign White Amerindians of Semitic–Moorish stock

4. Legal & Diplomatic Recognition Demands

- The United States and international bodies shall:
- Recognize the **paper genocide** enacted against the tribe
- Acknowledge that “whiteness” was seized, not lost
- Reinstall Ben-Ishmael bloodlines to their **original political class**

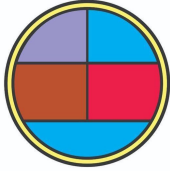
VII. CONCLUSION

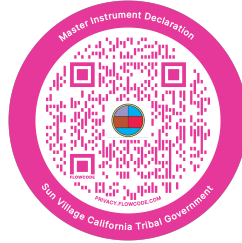
