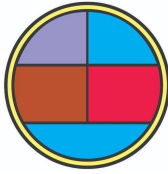

## « PREAMBLE »

To all peoples, nations, governments, courts, archives, and ancestral spirits:

A legal reinstatement.

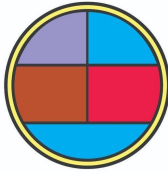

SECTION II. GENETIC AND FORENSIC EVIDENCE

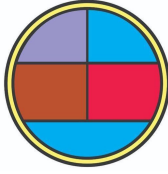

- These acts constitute **paper genocide** under the UN Genocide Convention.

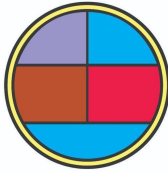

## SECTION V. PROTECTED RIGHTS OF TRIBAL LINEAGE HOLDERS

This Genealogical Restoration shall be:

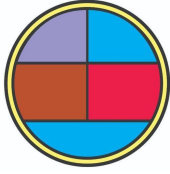

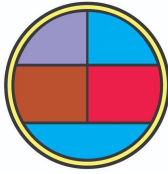

### THE GRAFTER'S HAND

##### SECTION II. THE JACOBIAN ORIGIN OF EUGENICS

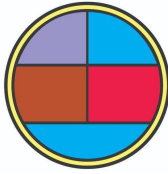

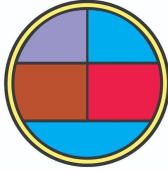
### SECTION IV. INVENTING “WHITE” AND “BLACK”

Because we were:

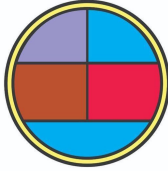
- **Mobile**, resisting county jurisdiction

## SECTION VII. LEGAL ASSERTIONS

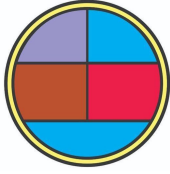

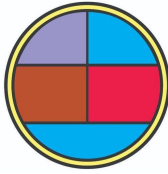

### THE ZOUAVES OF THE INTERIOR

#### The Ben-Ishmaelite Military Legacy and the Camouflaged Regiments of Tribal America

#### SECTION I. PREAMBLE TO A DISGUISED MILITARY LINEAGE

We, the sovereign descendants of the Ben-Ishmael Nation, formally reinstate the military legacy of our tribal regiments — erased, rebranded, and absorbed under white colonial frameworks — as a rightful part of America’s indigenous martial history.

- Operated as light infantry and mobile patrols

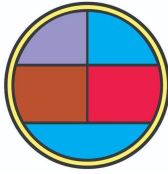
These were not mere stylistic choices. They reflected the martial culture of:

Ben-Ishmaelite Zouaves enlisted not as patriotic Americans, but as:

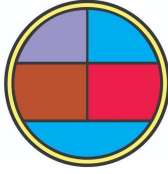

- Ignored in military history despite foundational contributions

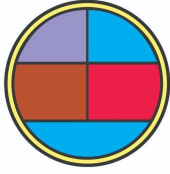
We now issue sovereign correction:

They were the shield of a nation that never fell — only erased.

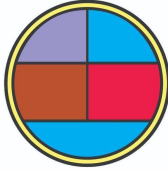

### THE NATURALIZATION TRAP & THE INVERSION OF WHITENESS

How the United States Reclassified the Original “White” Tribes as Black, Colored, and Alien

#### SECTION I. INTRODUCTION

Before the United States conceived of race as color, “white” was a **legal status**, a **treaty classification**, and a **designation of trust capacity** — not a phenotype. The Ben-Ishmael Tribe, along with countless other Semitic, Moorish, and Amerindian families, held **original “white” status** under this legal framework. Those granted this legal “whiteness” included:

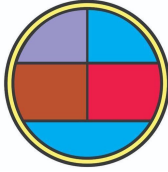
- **Moorish and Arab tribal families** from the Maghreb, Levant, and Arabian Peninsula

### SECTION III. THE NATURALIZATION ACT (1790): THE LEGAL COUP

The Naturalization Act of 1790 limited U.S. citizenship to “free white persons,” effectively creating a **class gate** for those who weren’t already sovereign. But this act:

- Reassigning original white-status families as “Negro” or “Gypsy” based on non-assimilation

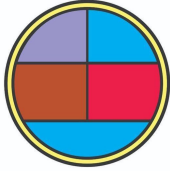

Modern historians often claim that Morocco, Indiana was named after the North African kingdom by settlers with fanciful ideas. This is false.

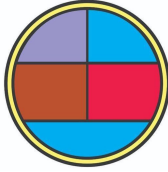
- The name “Morocco” existed on **Indigenous and colonial maps of the Americas** centuries before French colonization in Africa.

### THE PAPER SLAVE TRADE

#### How Census Classifications Became Shackles for Sovereign Tribal Peoples

The transatlantic slave trade is widely documented. The Ben-Ishmael Tribe:

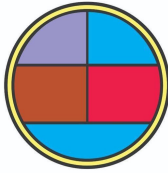
- Held **treaty-recognized land patents** across Indiana, Illinois, Ohio, and Kentucky

### Morocco, Indiana: The True Capital of the Forgotten Empire

#### How the Original Seat of Tribal Governance Was Erased, Repurposed, and Misremembered

#### SECTION I. INTRODUCTION

Long before the state of Indiana was overlaid with colonial borders, it was governed by tribal networks that spanned the Ohio Valley, Great Lakes, and Mississippi River basins. The name “Morocco” (المَرْك) (Al-Marak: to cut, to speed, the/to center) is not incidental. It holds layered historical truth:

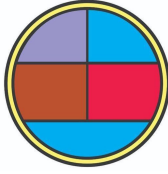

This population consisted predominantly of **Ben-Ishmael descendants**, Redbone affiliates, and Moorish tribal families who had refused to relocate under Indian Removal mandates.

The name was not imported — it was **retained**.

### SECTION III. THE REAL “MOROCCO”

Contrary to popular belief:

In Morocco, Indiana:

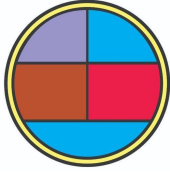
- Marriage, inheritance, and trade were governed under oral tribal law and Moorish-Islamic customs

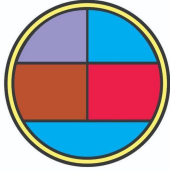

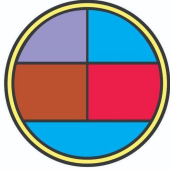

#### SECTION II. THE RISE OF THE ADMINISTRATIVE STATE

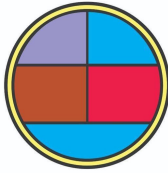
Between the late 18th and early 20th centuries, the United States evolved into what scholars call a **bureaucratic republic** — where:

### SECTION IV. TRUSTS, PROPERTY & THEFT BY ADMINISTRATION

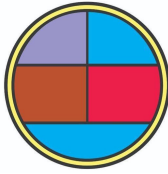
