APPENDIX V – LAND DEED SUPPRESSION AND TERRITORIAL THEFT

Annexed to the Declaration of Restoration of the Ben-Ishmael Nation
Filed under the Authority of the Sun Village California Tribal Government (Bani Al-Shams)

I. PURPOSE

This appendix documents the **systematic suppression, forgery, and destruction of tribal land records** belonging to the Ben-Ishmael Nation, carried out through county, state, and federal collusion from the late 1700s through the 20th century.

It further restores the **original territorial claims**, land deed designations, and estate jurisdiction of the Ben-Ishmael families across key migration corridors, including **Indiana, Illinois, Ohio, Missouri, Kentucky, Arkansas, and Southern California**.

This serves as both a **title correction** and **geopolitical reinstatement** of sovereign territory under tribal and admiralty law.

II. ORIGINAL LAND HOLDINGS & SETTLEMENTS

The Ben-Ishmael Nation held and occupied land through a combination of:

- Oral treaty recognition
- Marital and tribal alliances
- Patents, pre-emption claims, and unrecorded transfer deeds
- Zouave military grants and veteran homesteads
- Islamic burial grounds, masjid plots, and agricultural commons

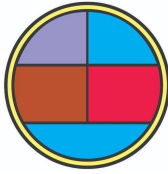
Notable early settlements included:

- **Beaver Township and Morocco, Indiana** (Laid out 1851, unincorporated capital)
- **Cairo, Illinois** (strategic river juncture)
- Cherokee-Redbone corridors in Missouri and Arkansas
- Undocumented Islamic farming colonies in Ohio River Valley
- Later West Coast dispersal zones, including Los Angeles County

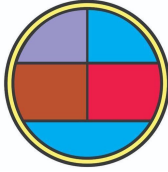

III. PATTERN OF SUPPRESSION

1. Redistricting & Cartographic Erasure
 - Tribal settlements intentionally omitted from official township plats
 - Towns like *Morocco, Indiana* stripped of tribal designation and reclassified as “white trash districts”
 - Geographies were renamed, redrawn, and overlaid with settler names to confuse jurisdiction
2. Deed Suppression & Title Voiding
 - Land patents held by tribal Moorish families were flagged for “irregularity” and voided
 - Probate court never recognized Islamic oral transfers or tribal inheritance systems
 - County registrars refused to file or recognize deeds from Ben-Ishmael tribal trustees
3. Forced Absenteeism
 - Families forcibly removed, “vagrant laws” enforced
 - “Land abandonment” codes used to justify seizure of fully occupied parcels
 - Absentee titleholders often deemed dead or ineligible due to misclassification as “Negro” or “Mulatto”
4. Constructive Fraud Through State Institutions
 - Courts, police, and sanitation boards coordinated to condemn and bulldoze “gypsy” encampments on tribal lands
 - Ben-Ishmaelite mosques, cemeteries, and schoolhouses were leveled or reappropriated by churches or state entities
5. Corporate Seizure & Eminent Domain Fraud
 - Railroad, energy, and real estate companies used dummy corporations to quietly purchase or confiscate tribal lands
 - Public records retroactively altered to remove original owner names
 - Displaced families offered no compensation

IV. LEGAL CLAIMS AND EVIDENCE

The following are hereby documented and entered into the record:

- **Original land title fragments and testimony** preserved through tribal oral record (recognized under Indigenous legal systems)
- **Cadastral overlays** from pre- and post-Civil War Indiana showing removal of Ishmael settlements
- **Military land grant voidances** traced to Ben-Ishmaelite Zouave descendants
- **DNA and surname continuity** in current land claim zones
- Witness affidavits from tribal elders and *Sun Village California Trust* surveys

These comprise **admissible evidence under international law**, UNDRIP, URR®™ frameworks, and tribal adjudicative systems.

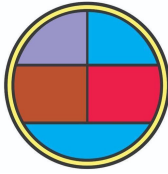
V. RESTORATIVE JURISDICTION AND TERRITORIAL RECLAMATION

1. Recognition of Morocco, Indiana as the Capital of the Ben-Ishmael Nation
 - All municipal encroachments nullified
 - Original grid restored in tribal maps
 - Reintegration under Sun Village jurisdiction
2. Restoration of Land Trust Capacity
 - Land titles previously dissolved through fraud reinstated under the **Tribe Up Registry™**
 - Tribal trust reconsolidated through the Dynastic Bloodline Trust of Mohamed Hasan Buhijji
3. Sovereign Immunity Over Reclaimed Territory
 - Land formerly held by Ben-Ishmaelite families declared exempt from state taxation, seizure, or commercial exploitation
 - Commercial claims by developers, counties, or banks declared invalid unless reconciled through tribal court
4. Tribal Geographic Codes and Boundary Restoration
 - Original tribal topography reinstated through geospatial overlays
 - Land claim zones catalogued under:
 - **BI-MW-01 through BI-MW-24** (Ben-Ishmael Midwest Zones)
 - **BI-CA-01 through BI-CA-05** (Ben-Ishmael California Zones)

VI. DECLARATION OF LAND TITLE RESTORATION

We, the Sun Village California Tribal Government and the surviving trust representatives of the Ben-Ishmael Nation, declare:

- All original tribal lands suppressed through paper genocide, title fraud, and cartographic erasure are hereby restored in standing and sovereignty.
- We hold trust authority to issue **Tribal Deeds, Zouave Veteran Grants, and Ben-Ishmaelite Territorial ID Codes** to verified descendants and tribal members.
- These lands are not U.S. property. They are sovereign extensions of the **Bani Al-Shams Trust Confederation**, governed by divine law, tribal ordinance, and universal reservation of rights.

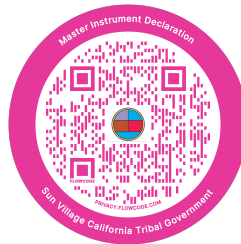
