### Warren - Update on Facilities:

Shed is nearly done, only some minor touches in the interior need to be finished.

Blower: Discussed need for 2nd battery. Blower is intended to clear the PB courts, not dry them. Warren did not see a need for a 2nd battery. A note will be posted regarding the blower and it's intended use is for clearing the courts, not drying the courts

VAPTOR: Warren explained what a VAPTOR was and how it could help dry the PB courts. Prices range from \$3,200 - \$3,900. Dollars are not currently in the budget. Re-allocating dollars from other projects, private fundraising and requesting dollars for next year were discussed. No final decisions were made.

Ball Machine: The ball machine is in. Warren proposed setting up tutorial classes to educate people on proper use. Rules as to when the ball machine can be used were discussed. LRC will manage the Ball Machine.

Fence: Fence repair is scheduled to begin next week. Fence will be replace on courts 1-4 on the marsh side of the courts.

Trees: A brief discussion was held regarding replacing trees downed in the recent storm. It appears that this is a decision to be made by the golf course.
