STATEMENT OF TRUST

In registering my child(ren) into the Tabernacle Christian Academy, I realize the following:

- The registration fee is non-refundable.
- The Tuition Payment Plan has been set up for my convenience of paying my child's tuition due for ten (10) months instead of in one lump sum.
- The first payment of said tuition is due before my child enters school to avoid additional costs and penalties.

Should my child(ren) be withdrawn from TCA either because of my undertaking or the school's disciplinary action (despite the situation or circumstance), I understand:

- I will be in default of the above-mentioned tuition payment plan.
- I will be liable for two (2) remaining months of tuition payments to cover cost of books, supplies and materials ordered on my child's behalf for anticipated use during the complete school year.
- Any defaulted tuition or tuition payments overdue by a period of more than 30 days will be subject to collection fees and/or court costs.
- Under no circumstances will my child's record or student transcript be released until TCA has collected all outstanding tuition and school fees.

I understand that my tuition payment remains the same if my child is absent any days within the ten (10) month period. Childcare (ages 2½ - 5) is a set rate whether my child attends school or not. In addition, I understand that no report card(s) will be issued on behalf of my child(ren) at the end of the school year until all fees are paid in full on my account.

I further agree to hold the school and its agents harmless for any liability to my child or any guardian or parent thereof because of any claims for my child against the school or any agent thereof because of any injury or alleged injury to my child. Should legal action, for any reason, be taken against TCA or any employee or agent thereof on my child's behalf, and the school or its agent not be found at fault, I agree to pay any attorney fees, court fees, damages or other costs the Tabernacle Christian Academy or its agent should incur to defend itself against such action.
