**FMI**- For More Information / **FEO**- For Exhibition ONLY / **Obed Titlists FEO**- dog with title may enter class in which title is held for PRACTICE ONLY / **MNE** or **MNC**- dog may not enter or compete in a class in which title is held / **MENHC**- dog with a title must enter the next higher class / **No majors**- dogs with a major win at a Point Show may not compete in conformation / **FAR** or **FAJ**- 1st available ring or judge / **MAP**- Minimum age of puppy allowed to enter breed competition (MAP at Match Shows is usually 3 mos but sometimes clubs invite two mo old pups to enter). The MAP for Obed Classes, Plan A Matches & Point Shows is always 6 mos / **RorS**- outdoors rain or shine / **P.S.**- Puppy Sweeps (Cash Prizes). Dog must also be in a Regular Class / **Specialty**- only that 1 breed may enter / **Bal**- Balance of / **POC&OT** or **POT**- Parade of Champions & Obed Titlists or Parade of Titled Dogs / **JrShow** or **AdShow**- Junior or Adult Showmanship (Handling) / **Vets**-Veterans
