

Broussard Retriever's Dog Boarding Agreement

This Boarding Agreement ("Agreement") is entered into by and between Broussard Retrievers, LLC ("Facility") and the undersigned pet owner ("Owner"). This contract outlines the terms and conditions under which services will be provided to the dog(s) listed below.

3. Boarding Policies:

- **Toys and Personal Items:** Broussard Retrievers cannot guarantee that toys, blankets, or beds will be kept in the same condition as brought in. For safety reasons, tennis balls and rawhides are NOT allowed.
- **Vaccinations:** All dogs must have current vaccinations to be eligible for boarding. The required vaccinations are:
 - **Rabies:** Must be current with proof of vaccination.
 - **Distemper, Parvovirus, and Parainfluenza (DHPP or DAPP):** Must be current with proof of vaccination.
 - **Bordetella (Kennel Cough):** Must be current within 6 months prior to boarding.
 - **Canine Influenza (H3N2 and H3N8):** Must be current with proof of vaccination (required by Broussard Retrievers for added safety).

It is the dog owner's responsibility to provide updated vaccination records to Broussard Retrievers annually. Dogs that do not meet these vaccination requirements will not be allowed to board.

- **Leash Requirement:** All dogs must be on a leash when entering or leaving the premises.
- **Food Requirements:** Owners are required to bring their dog's food for the duration of the stay. Changing a dog's food can cause severe upset stomachs. Each meal should be pre-portioned in individual sealed baggies. We will not accept large containers of food due to limited storage. Treats may be brought and given according to your instructions.

- **Reservation and Cancellation Policy:** Reservations are required for boarding. Changes to reservations must be made at least 72 hours in advance. Once a reservation is made, the full booking fee is charged, and there will be no refunds. In the case of cancellation, a credit will be issued for future use.
 - **Pick-up and Drop-off Times:**
 - Check-in/Check-out – Must make an appointment.
 - On check-out day: No charge for check-outs if picked up by 2:00 PM, Monday to Saturday. After 2:00 PM, a full day charge applies.
 - **Female Dogs in Heat:** We cannot board female dogs in heat due to potential safety concerns with other dogs.
 - **Risk of Communal Boarding:** The owner understands that communal boarding involves risks. Dogs may interact with other dogs during their stay, and while reasonable care will be provided, the unpredictable nature of dogs may result in injury. Owner agrees to accept full financial responsibility for any injury or issue that arises.
 - **Liability Waiver:** Broussard Retrievers' liability, in the event of any injury or loss related to the dog, will not exceed the current chattel value of a dog of the same breed.
 - **Aggressive Dogs:** For safety reasons, aggressive dogs will not be accepted for boarding. Dogs with a history of aggression may be asked to leave or will be denied service.
 - **Behavioral Assessment:** Upon check-in, all dogs will undergo a brief behavioral assessment to ensure they are compatible with communal boarding. Any concerns will be addressed promptly.
 - **Daily Updates:** Owners can request daily updates (photos/videos or phone calls) on their dog's status. Additional charges may apply for such requests.
4. **Health and Safety:**
- **Veterinarian and Emergency Care:** In the event of illness or injury, the owner authorizes Broussard Retrievers to seek immediate veterinary care, and the owner agrees to cover all associated costs. If necessary, the facility will contact the primary veterinarian listed above or an emergency vet facility if they cannot reach the owner.
 - **Health Guarantee:** The dog owner warrants that their dog is in good health, free from contagious diseases, and has no known behavioral issues that could affect other dogs or staff members. Dogs that are showing signs of illness or contagious conditions will be sent home immediately.
 - **Health Screening:** Upon arrival, each dog will undergo a brief health check to ensure they are fit for boarding. Any signs of illness or parasites may result in denial of service.
5. **Payment Terms:**
- The owner agrees to pay the boarding fees at the time of drop-off or as otherwise agreed in advance. Payment methods include cash or venmo. No services will be rendered without payment.
6. **Photo/Video Consent:**
- **Media Release:** By signing this Agreement, the Owner grants Broussard Retrievers, LLC permission to take photographs and/or videos of the dog during

their stay. These images may be used for promotional purposes, including but not limited to social media, website content, marketing materials, and advertisements. The Owner understands and agrees that these photos/videos may be posted publicly and may be shared across various platforms without further notification or compensation. If the Owner does not wish to have their dog's photos or videos used in this manner, they must notify Broussard Retrievers in writing before the start of the boarding period.

7. Indemnity Clause:

- The owner agrees to indemnify and hold harmless Broussard Retrievers, LLC, its employees, agents, and affiliates from any claims, demands, or liabilities arising from the owner's dog while in the facility's care.

8. Termination of Agreement:

- Broussard Retrievers reserves the right to refuse service or terminate the boarding agreement if any terms of the agreement are violated, or if the dog poses a risk to itself, other animals, or staff.

9. Facility Rules:

- Owners must comply with all posted facility rules regarding safety, behavior, and interaction with staff. These rules will be provided upon check-in and may be updated periodically.
- All dogs are required to be fitted with a collar and ID tag during their stay.

10. Agreement Acknowledgement:

- By signing below, the owner acknowledges and agrees to the terms outlined in this contract. The owner further certifies that all information provided about the dog(s) is accurate and complete to the best of their knowledge.
