

### **Letter from Bruce Turner on Solar Project**

January 7, 2014 @ 11:06 PM

Dear Owners.

Last year the owners voted to move forward on four projects. One of the projects was to look at a Solar System for the resort to eliminate the common area electricity and ultimately heat our pools and Jacuzzis with solar so we can eliminate the requirement for propane. During the past year while investigating this project several things caused me to pause and ponder this project.



I was originally under the belief that if we had a solar system at Las Palmas then we would have a Zero common area electric bill. I was under the opinion that a solar system would pay for itself and then electricity would be basically Free and actually making us money. The below items are things that I found out during the last year while investigating the solar project and I feel that I must pass this information on to all our owners so you are aware of the things I learned and come to your own independent decision about solar.

The physical area we have to install solar to the north of the club house between the mechanical room and the rental company maids supply room is only big enough to support an amount of panels that will

generate a total of about 50 percent of our electricity annually. This means that from our last years electricity bill of about \$44,000.00 dollars we would only save \$22,000.00 dollars for the year.

The estimated cost to install the above solar system will be between \$180,000.00 and \$220,000.00 dollars. (If you do the math for the above then our solar system would take about 10 years to pay for).

During the 10 years it will take to pay for the system we will be required to purchase maintenance, repair/replace damaged/worn parts, add or change upgrades and new technology.

Regarding new technology: Every time I think about solar and the way it is changing all the time it makes me think about the 8 track tapes, then cassette, then CD's, then micro chips and usb devices. The point I'm trying to make is if we spend \$220,000.00 to buy a solar system and only save 50% of our common area electricity costs what will our system be like in 10 years from now? I think everyone knows that if you still have an 8 track cassette then it is pretty much useless now.

Regarding the idea of heating all the pools and all the Jacuzzis with solar. There are three things to think about. 1. All of our pool and Jacuzzi pumps need to be changed to heat pumps and get rid of the propane heaters. The cost for this is significant and is not figured into the above cost. 2. When we looked at changing all the pool pumps and Jacuzzis to heat pumps we found a big logistical problem running the lines all over the resort from the solar panels to the distant pools and Jacuzzis causing a lot of work/cost to bury cable all over the resort. 3. We are back to the same problem as we originally developed. We have not been able to identify sufficient physical space to place solar panels to carry the additional power needed to heat pools and Jacuzzis. We have and will continue to be concerned in placing panels where they do not obstruct our views and are the least noticeable as we can make them be.



Conclusion: As a board member I will continue to strive to complete all projects voted on and passed by a majority of the owners regardless of my personal feelings. Regarding solar to be quite honest my current opinion is: "I don't know". I'm not afraid of the future and new things but I have to give pause when I look at something and question so many different aspects of should we or should we not do it. If

anyone is to ask me about solar right now I would have to say I'm not saying No Solar, but I'm saying No Solar right now. If we owners are going to spend this much money then I want to be a lot more sure about solar then I'm feeling right now. I keep thinking that any day someone will come along with a new technology and solve the problem.

Anyway, I wanted all owners to know what I know and make your own decision about how the board should proceed with solar. Currently we have only ordered the engineering drawings for the physical carport structure to support the solar system that we have the physical space for. This cost was supposed to be no more then \$5,000.

We have received the drawings but the contractor has failed to supply us with the CD of the drawings which is needed for an engineer to review, develop, legally get approved the structure. Because of the contractorsfailure to supply the CD we have withheld payment for the engineering drawings.

If there are any owners out there with more knowledge and a better option for Las Palmas please contact the board so we can discuss and bring it up at the owners meeting. We all want the same thing. We all want the best for Las Palmas. Thanks for taking the time to read my email.





Hello All,

As per the last owners meeting January 25, 2014, HOA board communicated to the owners and to all others present completed projects of 2013 that included a dedicated heated pool in the clubhouse area during the cold season. The purpose of this project was to ensure Las Palmas had a heated pool during the cold months for our guests and to allow them the use of our main attraction, the two water slides, when the temperature of the water is too low.



Because of this, at this time no other pool is scheduled to be heated. It is important to note that the requirement to heat this waterslide side of the clubhouse pool is a minimum of 25% guest occupancy in Las Palmas. This number is to prevent us from incurring unreasonable utility expenses when the occupancy is minimal. The HOA has been using this minimum requirement as past practice would like to continue unless there is a need for change.

Note: This percentage takes under consideration that there may be owners or guest of owners staying in Las Palmas unbenounced to neither the HOA or the rental companies.

Since the HOA is not involved in reservations or bookings the HOA does not know how many guests or owners are staying at one given time.

In the past to heat the entire clubhouse pool it may have taken three to four days. Now that we have divided the main pool the water slide side of the pool may take from 1.5 to two days to get it to the temperature needed, therefore it has been past practice for the rental company(s) to communicate the reservation numbers to Osvaldo at a minimum of 7 days in advance so that he can prepare.

Moving forward, so there are no future misunderstandings the following is the policy regarding our new dedicated heated pool area:

LAS PALMAS DEDICATED HEATING POOL POLICY

- The purpose of this policy is to minimize negative guest experiences by creating a standardization and an understanding where all parties involved including owners and guests are aware of Las Palmas heating pool policy.
- The HOA is committed to heat the water slides side of the clubhouse pool during the cold months up until the time of year the pool temperature reaches 78 degrees naturally and only during the periods where there is a minimum of 25% occupancy or 43 units total between both rental companies.
- The HOA will ensure the heating of the pool is initiated two days prior only when the rental companies communicate via e-mail at a minimum of four days in advance (i.e. Monday for upcoming weekend).
- The rental companies are responsible for e-mailing the reservation numbers to the HOA Manager Osvaldo Beltron and confirming receipt.
- Due to the possibility of misunderstandings any other form of communication other then e-mail will not ensure the heating of the pool when the minimum is reached.

Note: This policy is intended to improve the communication between the rental companies and the HOA for the common purpose of providing the best possible guest experience at Las Palmas.

The HOA Manager has been given direction to use discretion in the benefit of the guest should there be a situation where there are discrepancies.

The policy will be reviewed from time to time by the HOA to keep current. A guest friendly version will be posted around the clubhouse pool area for owners and guest to read.

Additionally,

The board is reviewing the clubhouse Jacuzzi heating policy in an effort to have this Jacuzzi dedicated to be operational year round between the hours of 8am-11pm. The Board will communicate an official position asap.

To log on to the internet, locate the log in information on the tag on the back of your modem. You may also hook up with your ethernet cable. In the example photos below:

the network you will join is : **ARRIS-1C02** 

The passkey is: AEBCF35D241B902C


Note: If your wireless device uses WPS, enter the WPS PIN if prompted: in this example, **77240187** 

Each modem will have its own passkey, so use the credentials located on the back of **your** modem to log in.

The TV service is also hooked up to your television sets and is viewed by changing channels via your TV. No box is required, so you must follow your TV owners manual for channel setup. A channel guide will be provided shortly for your reference use.

Service to the Villas 11-20 is scheduled for completion by next Friday. We will notify you when that installation is complete, and a schedule for the rest of the resort will follow.








### **Resort Update**


A <u>video link</u> is attached for you to observe the color changes in the fabulous new LED sign atop the Delphin building. As mentioned in an earlier post, we can control and regulate these colors for the season. The palm tree rope lights are also being replaced with the new LED technology.

In addition, work is moving rapidly to complete re-wiring and installing the cable TV and high-speed wireless high Internet system. Grande building and Villas 11-20 are now complete. Work has already begun on the Delphin building.



Please note that at this time, our TV signal is analog, and your TVs will have to be set up to scan all the channels for an analog cable signal. In the first quarter of 2015, Megacable will be upgrading to a digital high definition signal with bi-lingual audio. At that time we will advise you to reset your TV's for digital reception. Even with an analog signal, the much improved picture is of better quality than our old system, and far more reliable.  $\underline{A}$  channel chart is linked for your reference.

Our Internet service is totally independent of Telmex or service provided by the rental companies. You will no longer have to pay for these services, as renters are subsidizing both TV and Internet with the newly approved resort fee. <u>Instructions on how to log</u> on to the Internet were provided in an earlier post.




