## **Course Requirements**

- Documentation verifying status as a current or retired peace officer, public safety professional, armed security officer, military officer, or other qualified individual(s) to be reviewed and authorized by the lead Vista, LLC firearms instructor, who has completed a recognized original patrol rifle training program, including a patrol rifle qualification within the past year using the attendee's department-issued rifle
- Successful completion, with a passing score, of a pre-course and post-course patrol rifle qualification evaluated by course instructors, demonstrating safe weapon handling, proficiency, technical and tactical movement, and approved shooting positions
- A copy of your agency's firearms policies and procedures, including its use-of-force policy
- Duty handgun with duty belt, duty holster, and 3 magazines
- .223/5.56 AR-15–style patrol rifle with fixed "iron sights" and optional mounted non-magnified "red dot sights," both zeroed in before the course, and approved by the agency for on-duty use, subject to inspection and approval by instructors
- Single point or double point sling (no triple point slings), which is applicable to your patrol rifle
- 5 AR-15 style .223/5.56 magazines (metal or polymer Magpul style; minimum 30-round capacity), suitable for use with the attendee's rifle, subject to inspection and approval by instructors
- A handheld tactical flashlight or a rail-mounted weapon light
- 1,000 rounds of .223/5.56 duty or training ammunition, subject to inspection and approval by instructors
- 200 rounds of handgun ammunition, subject to inspection and approval by instructors
- At least five 5 .223/5.56 training or "dummy" rounds
- Tactical/BDU style clothing with tactical pants pockets, baseball-style cap, wrap-around eye protection, hearing protection (compatible with shoulder-fired weapons), and body armor (Level III +/-Level III A, or higher)
- A complete patrol rifle and handgun cleaning kit, and proper lubricants
- Sufficient physical strength and stamina to repeatedly manipulate and fire weapons during extended drills in varying weather conditions; attendees must be able to transition between standing, kneeling, and prone positions, and move forward, backward, and laterally
