Firearms: Instructor Development (Shotgun)

Vista Law Enforcement Training and Consulting, LLC, in cooperation with **????**, has scheduled this **24-hour POST-approved training program**, titled **"Firearms: Instructor Development (Shotgun)."** This training program is presented by current and retired law enforcement personnel who are experts in the use of firearms and are certified handgun/shotgun/patrol rifle instructors. Topics include:

- Required skills/preparation to be an effective firearms instructor in the classroom/on the range
- Essential requirements and forms that are mandated by Missouri POST for firearms qualifications
- Proper way to field strip a shotgun, clean the weapon, and apply proper lubricants to maintain the shotgun in proper working condition
- Missouri state statutes, federal laws, and U.S. Supreme Court rulings in the use of deadly force
- Discussion of tactical first aid and trauma training in officer-involved shooting incidents
- Written examination demonstrating understanding of instructed topics
- Preparation and presentation of a PowerPoint lesson plan related to firearms instruction
- Live-fire exercises on the firing range transitioning from the shotgun to the handgun
- Live-fire qualification course on the firing range with a shotgun

COURSE REQUIREMENTS:

- Attendees must have documentation as a current or retired law enforcement officer, public safety, or armed security officer, who has previously attended and satisfactorily completed a recognized Original Patrol Shotgun Training Program including qualification within the last year with their department-issued shotgun
- Ability to complete, with a passing score, a shotgun course of fire conducted and evaluated by course instructors before the beginning of the training program, to show safety and proficiency, including technical and tactical movements or advancements, as well as approved shooting positions
- Your agency's firearms policies and procedures, including your use of force policy
- Department-issued-12-gauge shotgun
- A hand-held flashlight (smaller tactical type flashlight preferred) or rail-mounted flashlight
- 150 rounds of low recoil (#6-#9 buckshot), 50 rounds of 00 Buck, and 20 rounds of shotgun slug ammunition
- Baseball-style cap with a bill, wrap-around eye protection, hearing protection, and body armor
- At least 5 rounds of training/"dummy" shotgun rounds
- Approved duty handgun with duty belt and duty holster, 3 magazines, and 50 rounds of handgun ammunition
- A shotgun and handgun cleaning kit and lubricants
