### **Firearms: Basic Patrol Rifle Re-certification Training Program**

Vista Law Enforcement Training and Consulting, LLC, in cooperation with **????**, has scheduled this **3-hour POST-approved training program**, titled **“Firearms: Basic Patrol Rifle Re-certification Training Program.”** This training program is presented by current and retired law enforcement personnel who are experts in the use of firearms and are certified handgun/shotgun/patrol rifle instructors. Topics include:

- Discussion and demonstration of patrol rifle fundamentals
- Proper way to field strip a patrol rifle and magazine, clean the weapon and magazine, and apply proper lubricants to maintain the patrol rifle and magazine in proper working condition
- Applicable Missouri state statutes, federal laws, and U.S. Supreme Court rulings in the use of deadly force by law enforcement/security officers in the performance of their official duties
- Live-fire qualification course on the firing range with a patrol rifle and handgun

This program is designed for all law enforcement, public safety officers, and security personnel required to carry a patrol rifle and need re-certification. Attendees must have documentation as a current or retired law enforcement officer, public safety, or armed security officer, who has previously attended and satisfactorily completed a recognized Original Patrol Rifle Training Program. Attendees must bring their department-issued handgun and .223/5.56 AR-15 patrol-style rifle with either fixed or mounted non-magnified sights (zeroed sights) and sling, duty belt with a holster, five (5) .223/5.56 AR 15 style magazines that are applicable for use with your patrol rifle (must be at least 30-round capacity), 2 handgun magazines (semi-automatics only) or 1-speed loader (revolvers only), 5 rounds of handgun ammunition, 50 rounds of rifle ammunition, baseball-style cap with a bill, wrap-around eye protection, hearing protection (which will not interfere with shoulder shooting of your patrol rifle), and body armor.
