Firearms: Basic Handgun Certification Training Program

Vista Law Enforcement Training and Consulting, LLC, in cooperation with **????**, has scheduled this **8-hour POST-approved training program**, titled **"Firearms: Basic Handgun Certification Training Program."** This training program is presented by current and retired law enforcement personnel who are experts in the use of firearms and are certified handgun/shotgun/patrol rifle instructors. Topics include:

- Classroom discussion and demonstration of handgun fundamentals
- Proper way to field strip handgun and magazine, clean the weapon and magazine, and apply proper lubricants to maintain the handgun and magazine in proper working condition
- Missouri state statutes, federal laws, and U.S. Supreme Court rulings in the use of deadly force
- Discussion of tactical first aid and trauma training in officer-involved shooting incidents
- Written examination demonstrating understanding of instructed topics
- Practical exercises using a "Blue Gun" handgun
- Live-fire exercises on the firing range with a handgun
- Live-fire qualification course on the firing range with a handgun

This program is designed for all law enforcement, public safety officers, and security personnel required to carry a handgun. Attendees must bring their department-issued handgun, duty belt with a holster, 3 magazines (semi-automatics only) or 2-speed loaders (revolvers only), 250 rounds of ammunition, baseball-style cap with a bill, wrap-around eye protection, hearing protection, body armor, and a handgun cleaning kit and lubricant. Attendees must possess the physical strength and stamina to repetitively manipulate and fire their weapons during prolonged drilling, in all weather conditions. Attendees must be able to get up and down from standing, kneeling, and prone positions, as well as move forward, backward, and laterally.
