### **Active Killer and Use of Force Liability Issues for Police Administrators**

Topics include:

- Civil liability and how agencies are exposed due to deficiencies in policies and procedures, training issues, and the response by officers to active killer incidents with inadequate training
- Differences between active killer incidents, hostage situations, and barricaded subjects
- Discussion of department policies and procedures in the response and investigations into both use of force and active killer incidents
- Training type and the number of hours officers have received in responding to active killer incidents, including applying currently accepted tactics and techniques
- Type of first aid and trauma training provided to personnel to treat victims or law enforcement officers who have sustained physical injuries in both use of force and active killer incidents
- Department capability to properly investigate a use of force and active killer incident
- How departments can take a proactive approach to prevent or eliminate the possibility of incurring civil liability in the use of force and active killer incidents
- “Garrity Rights” and how these rights apply to government employees that are part of the investigative process against both civilian and commissioned police personnel

This program is designed for first-line supervisors, mid-level managers, and police chiefs/sheriffs, who have the responsibility to investigate, supervise, and manage use-of-force and active killer incidents. This includes both criminal and administrative investigations. Missouri Police Officer Bill of Rights will be covered in depth.
