This program is designed for all new drug unit investigators/commanders or those wanting to become drug unit investigators/commanders. **Attendees must bring their department-issued vehicle, handgun, duty belt with a holster, 3 magazines, 200 rounds of ammunition, ASP Baton, baseball-style cap with a bill, wrap-around eye protection, hearing protection, body armor, and a handgun cleaning kit and lubricant.**
