## 4-C Niners General Meeting Minutes Thursday, May 4, 2023

-Tee leveling: scheduled to begin June 5th. Will take approximately 6 weeks. Temporary tees to be established (**no posting of scores during this time**)

-Hole 6:

The iron fence, brick wall and fence to the left of the hole surrounding the pumping equipment indicate out of bounds. **NO FREE RELIEF IS GRANTED (USGA Rule 18.2)** Until the fence surrounding the pumping equipment is complete, out of bounds is defined by the line connecting the brick wall to the left edge of the cart path. The left edge of the cart path defines out of bounds up to the street.

The edge of the penalty Area on #6 is defined as the TOP of the brick wall surrounding the water. A ball that comes to rest against the brick wall is not in the penalty area. **FREE RELIEF (USGA Rule 16.1)**. Gates in property fences are not immovable obstructions. Gates may not be opened. **NO FREE RELIEF.**
