 - i. Installed approx. 3 weeks ago but needs to be rotated so you can see it as you're driving. It's currently parallel to the road.
- b. Resident asked if the town could fix the drainage issue at the dock Church Rd & Great River Rd. JoAnn advised she will call the town to see if this can be addressed.
 - i. A few weeks ago, DPW was there and consulted. There isn't anything that can be done to drain the water. He's not allowed to do anything to cause the water to drain into the river. The town needs to be consulted further to determine what next steps can be taken.
- c. Bowling alley no update at this time.
- d. Kayaks Trish will find out what the arrangement is with St Anthony's. Resident Colleen Kaplan requests that it was put behind a fence as they're concerned with security and rental fees.
- e. Library in the post office Colleen Kaplan volunteered to clean up the area
- f. Emanual Church
