Dear Colleagues,

This letter is the call for dues for the 2024-2025 season of the Southern California Scholastic Fencing League.

This serves as your invoice.

Dues are:

- \$250 -- High School, 2 or more weapons programs
- \$250 -- Middle School, 2 or more weapons programs
- \$125 -- Middle or High School, 1 weapon program
- \$100.-- Programs only sending individual athletes

PLEASE MAKE CHECKS PAYABLE TO **"SO. CAL. SCHOLASTIC FENCING LEAGUE"**

Schools have the option of paying all at once or half by OCTOBER 6, 2024, and half by January 26, 2025.

FEES ARE DUE BY OCTOBER 6, 2024! Late fees are subject to a 50% increase in dues after NOVEMBER 3, 2024. If fees are not paid in full by January 26, 2025, the school shall be considered a non-league school and fencers from that school shall pay the full (non-league) registration and entry fees until the dues are paid in full, at which time event fees shall return to the levels listed below.

Further, if a new team joins the league AFTER the above deadlines, they shall only owe the regular dues appropriate for their school...no late fees shall be assessed.

Entry fee for individual competitions this season shall be:

For competitors from league schools (as listed at the top):

1) \$10.00 per person, per person per event, for fencers on a school sponsored fencing team, regardless of individual event.

For competitors from non-league schools:

1) Registration fee \$20 per tournament, plus \$60.00 per person, per weapon, for

independent fencers for individual events (foil 1 and 2, novice, epee/sabre 1 and 2).

2) Registration fee \$30 per tournament, plus \$50.00 per person, per weapon, for independent fencers **FOR HIGH SCHOOL CHAMPIONSHIPS**

All USFA equipment and safety rules will be followed at all tournaments
