Acceptable donations include clothing and shoes, accessories such as belts, backpacks, hats, scarves and handbags, household items such as blankets, bedsheets, towels and pillows, stuffed animals, and bicycles. Children's toys, books and baby gear are no longer accepted.

All items must be donated in secured trash bags. We will have a roll of trash bags available in the pod for use should packaging not be sufficient. Donations can be dropped off outside of these times, in which we will hang signage on the POD directing to place donations securely in the POD.

Do you drop your child off at school in the morning or pickup in the afternoon? If you answered yes and are wondering how you can help with the clothing drive, keep an eye out near the POD for any donations left outside. Please swing over to help organize and place any donations inside the unit.

In prior years the fall clothing drive was held in November. Last year, we decided to move the drive to September, in hopes that an end of summer clean-out would be much needed by families and it was a success! We did better than the prior two years. Here's to another successful clothing drive!

Book Fair: Still in need of a chair. Book fair will run from October 7th-10th. Family night will be Wednesday October 9th from 4-6:30pm in the outdoor classroom. There are YouTube videos available to walk volunteers through procedures and use of cash registers.

Halloween Town (Given by Evin Liljengren on behalf of Mia Park): The Halloween Town Committee is excited for the 2024 event. We think it's the best and biggest event of the year: Halloween fun for Chester families in a uniquely safe environment. Our team consists of 8 current and 2 alumni* CES parents (looking for someone to chair costume contest!).

Event includes Halloween Town in the cemetery, carnival games and food, along with parade and music downtown. Costume contest pending volunteers.

Huge PTO fundraiser – over 1/3 of our budget -- and we need all the help we can get! Greater volunteer involvement crucial for sustainability of this event. HT committee is focused this year on building volunteer support by:

- Appointing a volunteer coordinator: Evin Liljengren
- Communicating with Carolyn Gbunblee, JW principal, so dance is not scheduled on same date. Allows us to recruit CES alumni (7 & 8th graders) volunteers. Aaron thanks Carolyn for her willingness to help.
- Contacting VRHS athletic teams and local organizations.
- Advertising the event and volunteer needs early.
- Asking room parents to help get parents involved.

Started using QR codes and calendar links on flyers and emails to make it easy for parents.

Motion by Evin to formally request a spending budget of up to \$1,000 for Halloween Town expenses including: pathway lighting for safety (\$100); game creation (\$100); lit, stay-on-path signs (\$50); port-o-potty (\$200); food/game tickets for volunteers (\$200); straw bales (\$50); and game prizes (\$200). 2nd by Jen Rice, vote unanimously approved.

Mini-Grants (Given by Jen Rice on behalf of Caitlin Calder):

Cultural Arts: Tyson not present to discuss; however, Laura McGuire has volunteered to coordinate for this school year. Jen Rice to connect her with Tyson and Adele McAndrew for further instructions.

Sign-ups will also be available at Curriculum Night. She plans to send out a Teacher Favorites survey to all the teachers to assist in treat and gift buying ideas.

Heart Cart (Rebecca Sinusas): The Heart Cart is back! Rebecca is coordinating with Andrea Selmer and the Teacher Enrichment Committee. Plan to have one grade donate goodies per month with Student Leaders and Kindness Ninjas distributing rather than parent volunteers.

Treasurer's Report (Heather Cobb): Evin has stepped down to focus on Halloween Town. The executive board has appointed Heather Cobb as interim treasurer. Heather distributed and reviewed the treasurer's report.

Income

We raised \$551.78 in donations for the back to school teacher luncheon and received \$3.35 in bank interest.

Expenses

Our PTO insurance for this fiscal year is \$699.00. We spent a total of \$620.12 on the back to school luncheon; \$552 was payable to Wheatmarket and \$68.12 was reimbursed to Jen Rice for drinks, salads, and miscellaneous supplies. \$68.34 was used from our Teacher Appreciation luncheon as monetary donations did not cover the full amount.

Additional Comments

This year, we need to raise \$17,067.87 towards next year's budget. This amount is calculated as our current year budget plus a 25% buffer, less what we have in savings.

Old Business (Jen Rice)

- <u>Survey</u>: A survey of parents was completed at the end of last school year. She plans to share the results with committee chairs but will table further discussion until next meeting due to time constraints.
- <u>Open Committee/Chair persons</u>: Aaron Zain planning to create FB posts with descriptions of each open position. Further discussion tabled until the next meeting due to time constraints.

New Business: Parent Engagement; Tabled until next meeting.

- James G requesting dates for Holiday Craft Fair (tentative Dec. 6th) and Bingo Night due to high demand of gym space from the community.
- James G requesting assistance from the PTO in fundraising for a new saltwater fish tank for the school. The fish tank was originally provided with contributions from the community many years ago. Estimated cost between \$8,000 and \$9,000. Tiffany Shorey suggesting a dunk tank fundraiser, Rebecca Sinusas suggesting Penny Wars.
