## POLL WATCHER QUALIFICATIONS

To be a poll watcher, a person must be a qualified registered elector of the county in which the election district for which the watcher is to be appointed is located. Poll watchers must be identified and must receive official county credentials in advance and must be assigned to specific precincts. When a poll watcher is not serving in the election district for which the poll watcher was appointed, he or she may serve in any other election district in the same county in which the poll watcher is a qualified registered elector.

Each poll watcher must be provided with a certificate from the County Board of Elections, which states the poll watcher's name and the name of the candidate, party, or political body he or she represents. Poll watchers are required to show their certificates when requested to do so. If a poll watcher loses his or her certificate or if the certificate is destroyed, the poll watcher may appear before the Court of Common Pleas on election day and after swearing an oath or affirmation may immediately receive a replacement watcher's certificate issued by the Court.

Individuals may not serve as poll watchers except as specifically described above. In Pennsylvania, a Poll Watcher and Poll Challenger is the same thing.

## POLL WORKER REQUIREMENTS

In general, you must be registered to vote in the county where you wish to work.

Additionally, government officials and government employees are not allowed to serve as poll workers. Exceptions exist for district judges, notaries public, and members of the Pennsylvania National Guard. Likewise, you are generally not allowed to serve if your name appears on the ballot.

Poll workers generally work for the entire day on election day, from before the time the polls open at 7:00 am, until after the polls close at 8:00 pm.

Counties train poll workers on their election day duties.

All poll workers are paid for the time they spend working on election day.

## FYI

*From the office of Andrea Raffle:*

We are looking for Regional Election Integrity Directors that would assist myself in recruiting and training volunteers across the Commonwealth. Most of these positions will be Congressional District based and will cover 2 Congressional Districts. We are still looking to hire directors in: Philadelphia, PA (PA-02/PA-03), Bucks and Montgomery County (PA-01/PA-04), South Central PA (PA-10/PA-11), Chester and Delaware Counties (PA-05/PA-06), The Lehigh Valley (PA-07/southern PA-09), and Southwest (PA-13/PA-14).

This position is full time and primarily consists of recruiting volunteers at events and through recruitment calls; training volunteers on how to apply to be a Poll Worker as well as training them to be a Poll Watcher on Election Day; and then lastly will be responsible for shifting and credentialing volunteers in their region. As this is a political full time position this does consist of events and trainings during evening hours and weekends. Salary is in the range of 40-45k dependent on experience and this position only lasts through the November Election.
