

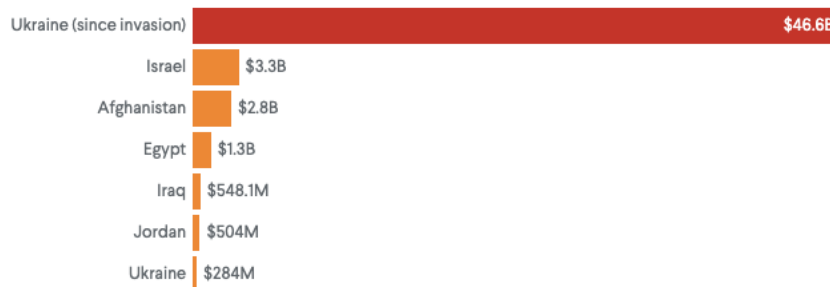

### Biography

American politician of the Democratic Party; graduated from the University of Delaware and Syracuse University. Biden was admitted to the Delaware State Bar Association in 1968. In 1969, he co-founded the law firm, Biden and Walsh, where he served as an Attorney. He worked as a public defender before seeking public office. From 1970 to 1972, he served as a Member of the New Castle County Council. In 1972, he was elected as a Member of the United States Senate from Delaware. He served as a Senator from 1972 to 2009. Between 1991 and 2007, he also served as an Adjunct Professor at the School of Law of Widener University. In 2009, he was elected as the Vice President of the United States. He served as the 47th Vice President of the United States from 2009 to 2017. He served as the Benjamin Franklin Presidential Practice Professor at the Annenberg School and School of Arts and Sciences at the University of Pennsylvania from 2017. He is on unpaid leave of absence since April 2019. Currently, Biden is a Member of the Democratic Party of the United States, and serves as the President of CelticCapri, an S-corporation incorporated to record income from his book deals and speaking fees. He made an unsuccessful run for presidential election in 1988 and 2008. Currently, he is a Democratic Party nominee for the 2020 presidential election in the United States. Married to Jill; the couple has a daughter. Biden also has one surviving son, out of three children from his first marriage.

As reported by Christopher Bedford 08/17/2012, Joe Biden's "very good friend" and donor, John Hynansky, received a Private Investment Corporation, or OPIC taxpayer loan of up to \$20 Million dollars to open a business selling foreign luxury cars in a foreign country. John is a long time major donor to Biden's campaigns as well as President Barack Obama's. Joe Biden and Hynansky's ties to Hynansky date back to at least 1987, when Hynansky and his then-wife, Deanna, cut campaign checks for \$1,000 each, their business ventures dates back to 2009, (The previous year, Hynansky had individually contributed more than \$33,000 to the Obama-Biden ticket primarily through the Obama Victory Fund,) Hynansky and his family have contributed more than \$100,000 to "Joe Dirt" campaigns, including \$8,000 in 2020, and son, Michael (who helps run his car empire) lent the use of his Lear jet to Biden when he was a senator.

A half a million dollar loan in 2015 came as Biden's brother faced financial difficulties related to his acquisition of a multimillion-dollar vacation home, nicknamed "the Biden Bungalow," in South Florida. In 2019, the Politiko website published documents that showed that Vice President Joe Biden's younger brother James borrowed \$2.5 million from Hynansky. August 2021, Hynansky [secured](#) a \$24 million loan from the European Bank for Reconstruction and Development, the U.S. is a founding member of EBRD and provides 10% of its capital.

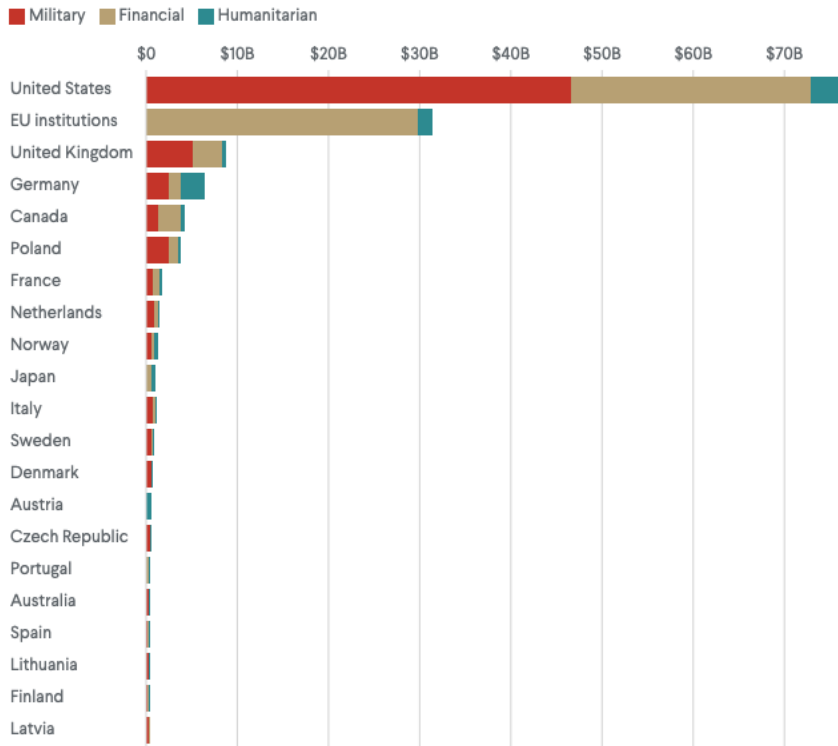
Years later, this filing showed that Hynansky controlled a generous Biden mortgage lender, 1018 PL LLC.

Starting in 1991 the company is the official distributor of Ford, Volvo, Jaguar, Land Rover, Porsche and Bentley cars. In addition to sales and service of vehicles, it is engaged in the construction, repair and sale of commercial and residential real estate. The company's market share of Jaguar Land Rover in Europe is now 25% and Biden also is **securing** the investments of the car magnate John Hynansky with Billions of taxpayer funded military aid.

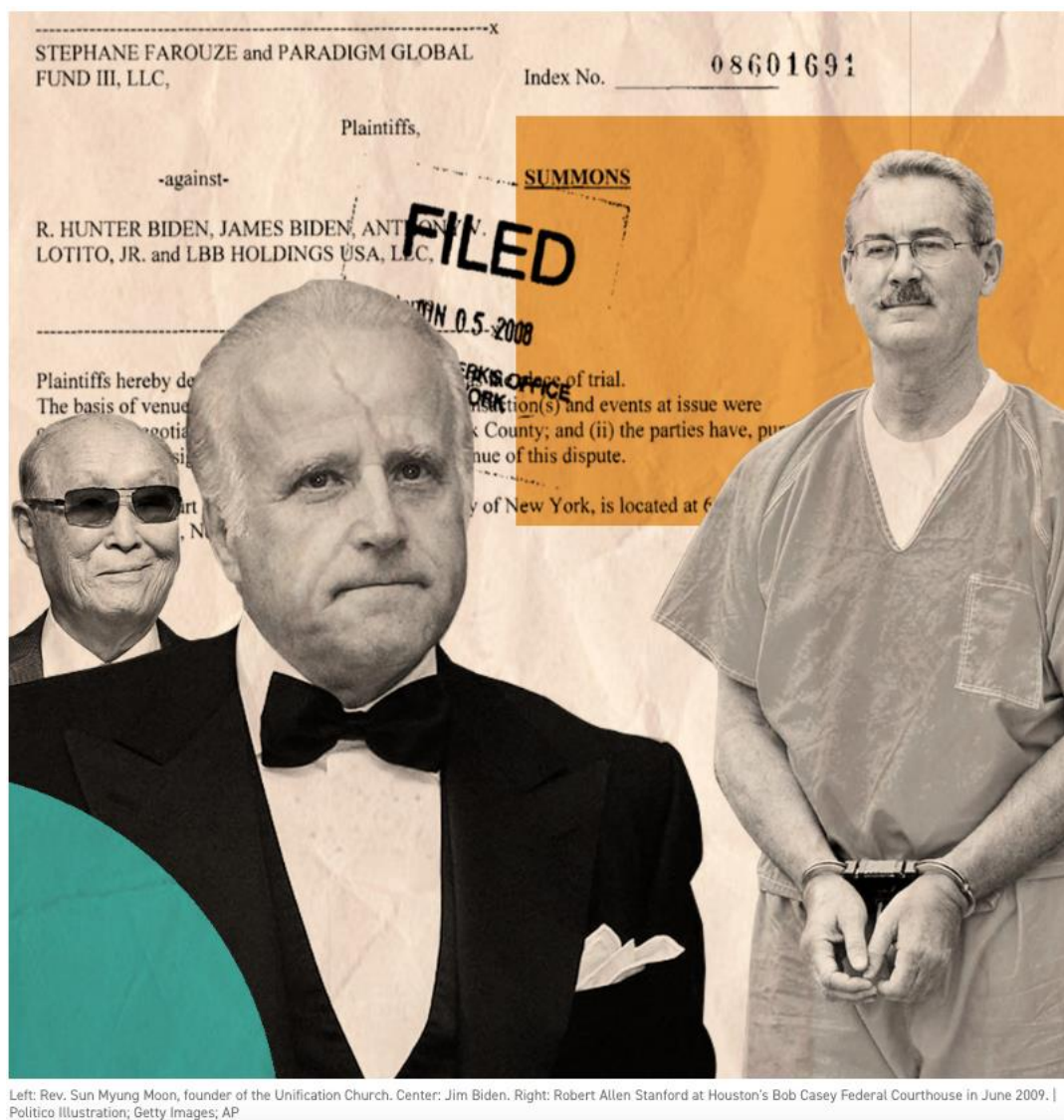


In 2012, American media outraged that the Federal Government's Overseas Private Investment Corporation [gave](#) \$20 million loan to Winner Import Ukraine to expand its automobile business, and construct and operate Winner AutoCity. They said that instead of helping their own business, the taxpayers fund allocates huge money for the construction of a VIP car dealership in Ukraine. Then came the 2014 John Bolton, George Soros and Joe Biden led regime change in Ukraine. Hynansky has supplied the police cars and ambulances in several regions of Ukraine. Since then, Joe's administration helped Hynansky's team in Ukraine prepare for the invasion warning them 13 days in advance of Putins' invasion and sent billions of dollars to help rebuild war-torn cities where Hynansky operates the largest number of showrooms and service centers specializing in Porsches, Jaguars, Land Rovers, and Bentleys, non-American brands. The president's close relationship with Hynansky high lights larger ethical questions, in line with Biden and his family members long history of financial interests directly affected by policies he endorses. Ethics watchdogs say the president's friendship poses a potential conflict of interest and demand a full accounting. How has the massive foreign aid, which includes open-ended humanitarian and economic assistance, been used and who has benefited from it, besides Biden accomplices.





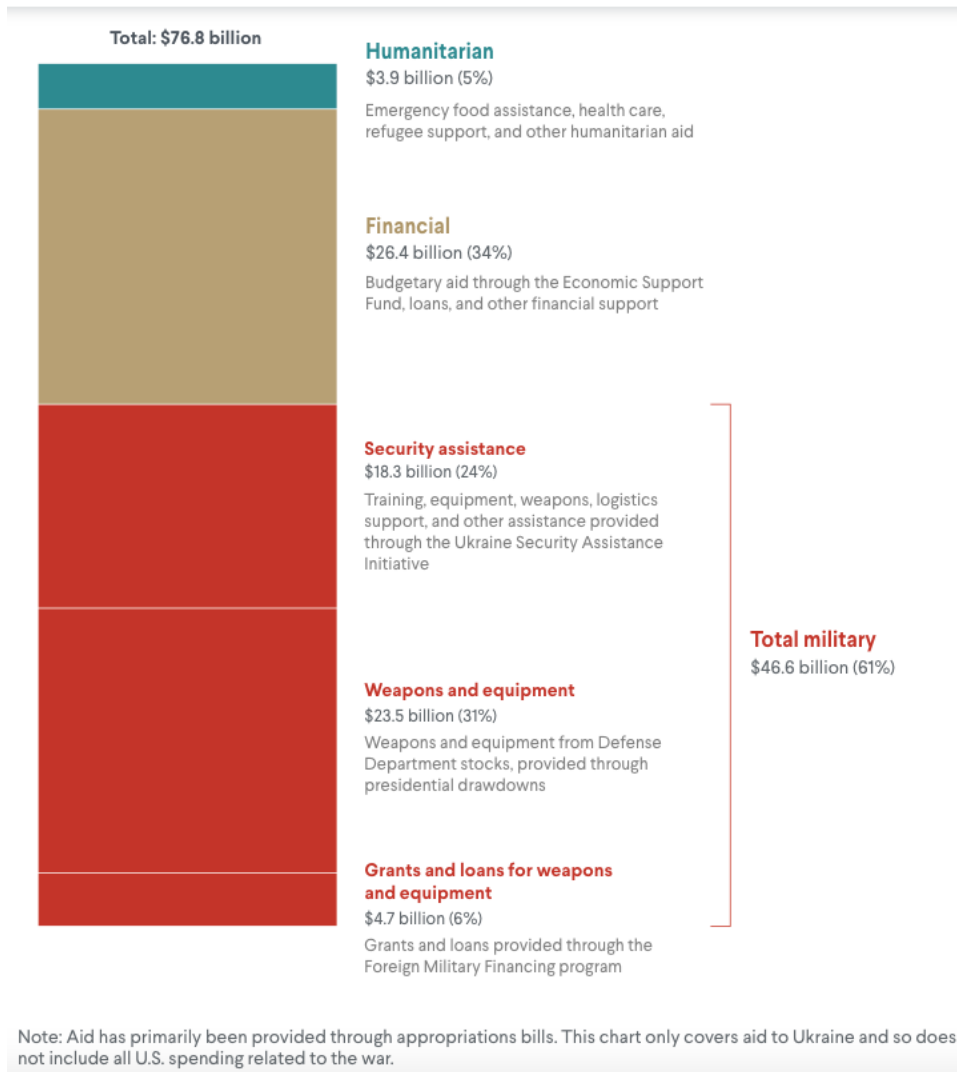
It was 2015 when Biden famously demanded the firing of the prosecutor investigating Burisma who was paying Hunter \$80,000 per month to serve on its board. Last week we covered a whole litany of recent revelations of lucrative dealings, concerns tied to China's government while Joe Biden was both in and out of office. Finally these have raised questions about his current policy toward Beijing.

Interesting Facts
While serving as a Senator, Biden served on the Senate Foreign Relations Committee, the Senate Judiciary Committee, and as the Chairman of the Judiciary Committee's subcommittee on crime and drugs. He also drafted and was involved in the passage of the \$1.6 billion Violence Against Women Act.
Biden was born in Scranton, Pennsylvania and moved to Delaware in the early-1950s with his family.
He is the recipient of awards including the Freedom Award by National Civil Rights Museum and the Medal of Freedom with Distinction.
Holds a bachelor's degree in history and political science from the University of Delaware, and a law degree from the College of Law at Syracuse University.
Reportedly, the Biden Cancer Initiative promoted nearly 60 partnerships with drug companies, health care firms, charities and other organizations that pledged more than \$400 million to improve cancer treatment.
Shortly after Biden became United States senator-elect, his first wife, Neilia and his three children met with a car accident in 1972. Neilia and one year-old daughter, Naomi died in the accident. Biden's sons Joseph and Robert were in critical condition at the hospital; Biden forced to hold his Senate swearing-in at the hospital beside his sons.
Reportedly Biden withdrew from the primary contest for presidential election in 1988 when he was accused of campaign speech plagiarism. In the same year, he was operated for two brain aneurysms.
Reportedly, Biden donated his senatorial papers to the University of Delaware in 2012. The papers included a collection of more than 1,850 boxes, along with 415 gigabytes of electronic records.
Biden's son, Robert is reportedly involved in many scandals including involvement in alcohol addiction and drug abuse, a divorce, dating his brother's widow, and was sued for child support by an Arkansas woman. He also served as a Director of Burisma Holdings, whose founder was involved in a money laundering case.
Biden ran for presidential election in 1988 and 2008. In April 25, 2019, he announced that he would run for presidential election of the United States in 2020. Currently, he is a Democratic presidential nominee for the 2020 presidential election in the United States.
He has been involved with creation of the Beau Biden Foundation for the Protection of Children, the Biden Cancer Initiative, the Penn Biden Center for Diplomacy & Global Engagement at the University of Pennsylvania, and the Biden Institute at the Biden School of Public Policy & Administration at the University of Delaware.
Biden was elected to the Senate at the age of 29 in 1972. He has won re-election five times and became Delaware's longest-serving Senator.
When Biden was a Senator, he traveled every day by train to Washington, D.C. from Delaware in order to take care of his injured sons. This earned him the nickname 'Amtrak Joe.'
Reportedly, Biden has a stuttering problem since his childhood, which got better when he grew up. Even at present, he still occasionally stutters when he is very tired.

Republicans are investigating whether those funds were intended to help his son's business interests in Ukraine. Less explored is whether U.S. tax money has also been used to protect or boost Hynansky's Ukrainian investments, meanwhile Winner executives have been clamouring for more U.S. military aid and direct intervention by Biden, Britain is providing less than 10% of what America is sending (despite ranking second) and Canada has admitted it can't meet Nato cash demands now. Billions of dollars have gone to unspecified areas, such as "security," "intelligence," and "training."

“” ‘There is no indication that the loan influenced Joe Biden’s official actions, but it furthers a decades-long pattern by which relatives of the former vice president have leaned on his political allies for money and otherwise benefited financially from the Biden name’, — [stated](#) the American journalists. Biden’s relatives have not been accused of criminal wrongdoing in their dealings. But over the years, several of their partners and associates have ended up indicted or convicted.

In the late summer of 2006 Joe Biden’s son Hunter and Joe’s younger brother, James, purchased Paradigm Global Advisors. On their first day they ordered the hedge fund’s chief of compliance to fire its president, according to a Paradigm executive who was present and James Biden laid out his vision for the fund’s future.



In 2009, Hunter and his friend Devon Archer set up an investment firm called Rosemont Seneca Partners (RSP). Another partner in the firm was Chris Heinz, a Heinz family member who was also the stepson of then-senator John Kerry. The startup's connections in Washington can be imagined.

“Don’t worry about investors,” he said, according to the executive, who spoke on the condition of anonymity citing fear of retaliation. “We’ve got people all around the world who want to invest in Joe Biden.” “We’ve got investors lined up in a line of 747s filled with cash ready to invest in this company,” the executive remembers James Biden saying. Also present in the room Beau Biden, who was then running for attorney general of Delaware, turned bright red. He told his uncle, “This can never leave this room, and if you ever say it again, I will have nothing to do with this.”

In James and Hunter’s five-year tenure at Paradigm became associated with a number of alleged and confirmed frauds, including Allen Stanford’s multibillion-dollar Ponzi scheme. The pattern of sketchy associations & possible conflicts of interest would continue with Hunter which led him to the board of Burisma and deals with firms connected to the Chinese state. Paradigm in 1989 was the brainchild of James Park, a son-in-law of the billionaire Sun Myung Moon, the founder of the Unification Church, a cult more commonly known as the “Moonies”. A third former executive at Paradigm claimed that at one point around 2008 or 2009, James and Hunter withdrew several million dollars from Paradigm’s coffers for their own use.

A spokesman for James and Hunter said no such withdrawals occurred.

An independent [audit](#) performed on the fund in 2008 by the Philadelphia firm Briggs, Bunting & Dougherty was filed with the SEC: “” the audit found accounting deficiencies at Paradigm, including a “failure to timely prepare financial statements” and a “failure to

reconcile Investment Advisors reimbursement of fund expenses.” Paradigm was still running and would soon attract attention for its associations with several criminal frauds.

In September 2008, with the financial system melting, an executive at Paradigm registered “Paradigm Stanford Capital Management Core Alternative Fund” with the SEC. The fund of hedge funds represented a partnership with the firm run by Allen Stanford. In February 2009, less than a month after Joe Biden was sworn in as vice president, Stanford was charged with a multibillion-dollar Ponzi scheme, one of the largest in U.S. history. Paradigm was not accused of participating in the scheme. Paradigm had also rented space to Francesco Rusciano, whose Ponta Negra fund shared an office and a phone number with Paradigm. In April 2009, the SEC [accused](#) Rusciano of a multimillion-dollar fraud.

James and Hunter began unwinding the fund in 2010. They never brought on any new investors. Negative press about Paradigm’s ties to fraudulent funds made James and Hunter wary of more scrutiny of “potential conflicts of interest or tie-ins to the Biden family.” As a result, the executive said, “They really just chose to liquidate the hedge fund and give back the money to the investors.

After Joe’s first Senate campaign in 1972, James embarked on a career as a serial entrepreneur, as Joe was entering the Senate and taking a seat on the Banking Committee, James obtained unusually generous loans from lenders who later faced federal regulatory issues. Joe Biden was in touch with two of those banks about his brother’s loans, once to scold a bank executive about invoking his name in attempts to collect on overdue payments. During the Obama years, James was a construction firm executive, the firm received a contract worth more than a billion dollars to build houses in Iraq while Joe oversaw the U.S.-led occupation of that country.

No sooner was freshman lawmaker Joe Biden seated on the Senate Banking Committee than James became the beneficiary of business loans that were described as unusually generous because of the relatively large amount of money he was able to borrow with little or no collateral and a lack of relevant prior experience.

In early 1973, James Biden and a business partner decided to open a nightclub. The pair had obtained a series of loans for \$80,000, \$60,000 and \$25,000 from Wilmington’s Farmers Bank. At least one of those loans was unsecured.

**NOW, THE LOAN** has triggered a \$426,000 suit filed against the bank by a Yeadon, Delaware County, man who took over the club and a consortium for \$500,000 by the First Pennsylvania, which is trying to force him to pay off the Biden loan.

"The bank didn't know the senator's brother is on the paper when he got the loans folded," says Salvatore J. Cardillo, a lawyer for the bank.

"The banks didn't do their homework," says Joseph P. Biden Jr., who was elected first Pennsylvania "They treated me like I was some kind of idiot," Biden says.

Biden would prefer to discuss the First Pennsylvania matter privately.

According to Hiden's 1975 liquor license application, his yearly income as an employee of Health Corp. of America, Valley Forge, was \$15,000 and his personal net worth, \$20,000.



"My only contact with First Pennsylvania was with a junior loan officer who wanted to see me about my brother's loan. I told him no. It was my brother's business. He should have said so."

**THE YEAR BIDDON** got his First Pennsylvania loan, the bank was put on the Federal Reserve Board's "watch list." First Pennsylvania Bank Chairman John Bunting conceded the Fed had expressed concern about bank finances.

The Fed's main concern was that First Pennsylvania's subordi-

Another figure tied to Farmers Bank, the politically connected financier Norman Rales, extended James Biden an unsecured loan. Rales, who did extensive business with Farmers, extended the loan to James through Joe Biden's former law firm, Walsh,

Monzack & Owens. One of the firm's partners, John T. Owens, was a Biden brother-in-law, having married Joe's sister and political confidante, Valerie.

After Farmers Bank nearly collapsed in 1976, forcing the Federal Deposit Insurance Corporation to bail it out. The crisis spurred several investigations into the bank's lending practices and political connections & dropping Delaware's credit rating from A1 to A because the state's finances were so intertwined with the bank's

Separately, the Justice Department began investigating whether Rales had defrauded the bank in his unrelated dealings with it. The DOJ also scrutinized unusual loans made by Farmers, including the Biden loan. In 1978, assistant U.S. Attorney Alan Hoffman — who would go on to serve as a top aide to Biden in the Senate and the White House — told the Philadelphia Daily News that the government found nothing improper about Farmers' loan to James.

Farmers was not the only bank to provide James & partners unusual funding, Philadelphia bank & First Pennsylvania where James and his partner were able to obtain a loan of \$500,000. (about 2 million in today's \$) Delaware's News Journal would report that the office of Pennsylvania's then-governor, Democrat Milton Shapp, had recommended James Biden for the First Pennsylvania loan. It also emerged that after the loan was made, First Pennsylvania met with Joe Biden to discuss it.

Joe Biden told the Philadelphia Daily News in 1978 he met with a junior loan officer, William Githens, was in fact a senior vice president. A year later, the man who took it over from him, Salvatore Cardile, was fighting First Pennsylvania in court, claiming the bank had set him up to take the failing club off of James Biden's hands.

In 1981, the FDIC sued James and his partners for outstanding loans to Farmers. In both instances, the Bidens told the press that Joe did nothing to help James get the loans.

Dr. Howard Krein, who is married to first daughter Ashley Biden, and launched his StartUp Health investment consultancy when his father-in-law was vice president. The company was later featured at a large health care tech conference run by the Department of Health and Human Services, and StartUp Health executives became frequent visitors to the White House while Joe Biden was President Barack Obama's No. 2.

Frank Biden, the president's youngest brother, runs a solar energy company, Sun Fund Americas, that reportedly signed a deal with the Ministry of Public Education in Costa Rica to develop renewable energy in the country, where Joe Biden also acted as the Obama administration's point man. Sun Fund has also benefited from US government-backed Overseas Private Investment Corporation loans for renewable energy projects.

Finally, Valerie Biden Owens, Joe's younger sister who ran all of his Senate campaigns and his presidential campaigns in 1988 and 2008, was also a senior partner in the

political messaging firm Joe Slade White & Company, according to Schweizer, and the firm received large fees from those campaigns, including \$2.5 million alone from Joe Biden's 2008 presidential bid.
