GRAPHIC: CARES Act and ARPA provided big bailouts for wealthy non-profit hospitals during the Covid-pandemic.

The "Fat Cats" did alright. Executives racked up packages frequently exceeding \$10 million per year. In one case, the CEO of Ascension Healthcare based in St. Louis, Missouri made \$13 million in 2021 – with more than \$22 million over 3 years.

Top systems saw their combined net assets soar 62%, or \$124 billion, in 3 years to 2021.

• Mayo Clinic: jumped 92 % from \$9.2 billion in 2018 to \$17.7 billion in 2021. Mayo Clinic CEO, Dr. Gianrico Farrugia, received a 27% raise in 2021

- Cleveland Clinic Health System: jumped 60% to \$15.6 Billion in 2021 CEO and President Tom Mihaljevic, M.D
- Intermountain Healthcare: jumped 63 % to \$11.6 billion Dr. Marc Harrison is the President and CEO

None complied fully with U.S. government price transparency rules





- Dr. Anthony Fauci is considered the nation's top infectious disease expert and chief medical advisor to the president. As director of the National Institute of Allergy and Infectious Diseases, he is the highest paid public servant in the country, making \$434,312 in 2020 and \$456,028 in 2021. Dr. Fauci out earned the president, four-star generals, and all 4.3 million of his colleagues.
- **Dr. Fauci was the third highest paid** federal employee in 2018 at \$399,625 and his pay increased to \$417,608 by 2019.
- In a 10-year period between 2010 and 2019, Dr. Fauci made \$3.6 million in salary.
- Dr. Fauci became the early face of the White House Coronavirus Task Force, which led to <u>hundreds of media interviews</u>.

Between Jan. 1, 2020, and June 15. 2021, Dr. Fauci participated in 354 television, radio, podcast, and online interviews, including lectures, panel discussions, speeches, and press conferences.

In 2004, Dr. Fauci got a permanent pay hike for his "biodefense research activities." His pay raise was justified because of his increased workload post-9/11 responding to bioterrorism threats and to prevent the next pandemic.


- When Dr. Fauci retires, he'll collect a more than \$355,000 annual retirement package the largest federal pension in history.
- For more than a year, NIH withheld public information about Dr. Fauci's finances, denying our Open Records request. In October 2021, we had to sue NIH to produce those records.
- Dr. Fauci's wife, Christine Grady is the chief bio-ethicist at the National Institutes of Health Clinical Center, making \$234,284 in 2020 and \$238,970 in 2021. Grady out earned the vice president.
- The Fauci household's net worth rivals \$11 million. That includes \$794,369 in gains for Dr. Fauci in the stock, bond, and money market portfolio during 2020. His total investment account was \$8.4 million and his wife's investments was another \$2.1 million.
- While NIH only gave OpenTheBooks.com a small portion of its redacted files on Dr. Fauci, U.S. Senator Roger Marshall (R-Kan.) forced the release of Fauci's unredacted 2019 and 2020 financial disclosures. Marshall cited OpenTheBooks investigations.

The life expectancy gap between men and women has widened more in the U.S. than in comparable countries

Methods

Life expectancy data in this analysis were gathered from the CDC, the OECD, the Japanese Ministry of Health, Labour, and Welfare, the Australian Bureau of Statistics, and the UK Office for Health Improvement and Disparities. Some life expectancy data for 2021 are estimates or provisional. For 2021 United Kingdom data, life expectancy data for England were used. 2021 data for Canada were unavailable and therefore excluded from the 2021 comparable country average. 2021 values for Australia, Japan, and the United Kingdom are averages of life expectancy estimates for males and females. Number on charts may not average to the comparable country average due to rounding. OECD data have a break in series for Canada in 1982, Germany in 1991, Switzerland and Belgium in 2011, and France in 2013. Comparable country average life expectancy in the chart "Life expectancy in years at given age, 2021" excludes the UK, Germany, and Canada, as data were not available for these nations for all ages. For health spending data, the 1991 data point for Germany is unavailable; from 1980-1990, health spending data in France is only available for 1980, 1985, and 1990. Therefore, data for France is only shown from 1990 onward. For comparable country average health spending in 2021, we used 2020 data points for the following countries due to missing 2021 data: Australia, Belgium, France, Japan, Netherlands, and Switzerland.
