
# deep dive #15: George Soros, the "Ringleader" that binds them all.

#### Who is George?

- Born **György Schwartz**, August 12, 1930 Hungarian-American businessman and philanthropist.
- 15 years old at the end of WWII
- moved to the United Kingdom in 1947, BSc of philosophy in 51, Masters in 54.
- by 1969 he launched his first Hedge fund called 'Double Eagle,'

- In 1993, the Open Society Institute was created in the <u>United States</u> to support the Soros foundations in Central and Eastern Europe and Russia

- 1995, Soros stated that he believed there can be no absolute answers to political questions because the same principle of reflexivity applies as in financial markets <a href="https://en.wikipedia.org/wiki/Reflexivity">https://en.wikipedia.org/wiki/Reflexivity</a> (social theory) reflexivity refers to circular relationships between cause and effect, especially as embedded in human belief structures. With economics it refers to the self-reinforcing effect of market sentiment, whereby rising prices attract buyers whose actions drive prices higher still until the process becomes unsustainable. This is an instance of a positive feedback loop. The same process can operate in reverse leading to a catastrophic collapse in prices.

#### Social Finance Example 1:

#### Immunisation Bond

The International Finance Facility for Immunisation (IFFIm), managed by the World Bank, is selling 5-year bonds, which yield between 30 and 33 basis points above similar-maturity US Treasury notes. The UK, France, Spain, Italy, Sweden and Norway have pledged \$4 billion over 20 years to Microsoft Corp. founder Bill Gates' GAVI Alliance to fight diseases such as hepatitis and yellow fever. By selling bonds backed by the contributions, the countries will enable the money to be spent immediately. The GAVI Alliance says the money will save 10 million lives in countries from Afghanistan to Zambia. IFFIm has AAA ratings from Moody's Investors Service, Standard and Poor's and other rating agencies.

#### Social equity lens

Incorporation of a gender, diversity and inclusion analysis into processes and decision-making, including consideration of intersectionality. A social equity lens will be incorporated into all elements of the SFF's design and delivery to encourage processes and decisions that remove barriers, address systematic bias, and promote equal opportunity for all.

#### Social equity lens investment

The definition of a social equity lens investment will be finalized in partnership with selected wholesalers, building upon existing definitions in use in the social finance sector. ESDC may also work in partnership with the selected wholesalers to further strengthen the use of a social equity lens in alignment with the objectives of the SFF. For the purposes of this Call for EOI, "social equity lens investments" may broadly refer to capital directed towards:

- social purpose organizations that are majority owned or led (more than 50%) by equity-deserving groups
- social purpose organizations that promote workplace equity (in other words, have processes in place to address structural disparities and constraints around the leadership of equity-deserving groups, such as the existence/development and implementation of policies around compensation, career progression, et cetera)
- social purpose organizations that offer products or services aiming to address the root causes of social issues and
  the diverse needs of equity-deserving groups (for example, a project that educates and engages boys and men to
  prevent violence against women)
  - Fund managers are required to incorporate a <u>social equity lens</u> to ensure diversity and inclusion considerations are incorporated into decision-making processes and outcomes, to benefit equity-deserving groups that face barriers to economic inclusion and lack access to investment capital
  - In 2017, the government of Pakistan ordered the Open Society Foundations to cease operations within the country
  - 2017 Open Society Foundations and other NGOs which promote open government and help refugees claim to be targeted for crackdowns by authoritarian and populist governments including <u>Liviu</u>
     <u>Dragnea</u> in <u>Romania</u> and right-wing figures <u>Szilard Nemeth</u> in <u>Hungary</u>, <u>North Macedonia</u>'s <u>Nikola Gruevski</u>, who called for a "de-Sorosization" of society, and <u>Poland</u>'s <u>Jarosław Kaczyński</u>, who has said that Soros-funded groups want "societies without identity"
  - November 2018, Open Society Foundations announced they are ceasing operations in <u>Turkey</u> and closing their <u>Istanbul</u> and <u>Ankara</u> offices due to "false accusations

George Mark Malloch Brown, Baron Malloch-Brown<sup>[5]</sup> KCMG PC (born 16 September 1953) is a British diplomat, communications consultant, journalist and former politician serving as president of Open Society Foundations since 2021, having previously served as Deputy Secretary-General of the United Nations under Kofi Annan from April to December 2006. A former member of the Labour Party, he served as Minister of State for Africa and the United Nations in the Brown government from 2007 to 2009.

Born in Marylebone, Malloch Brown studied at Magdalene College, Cambridge and the University of Michigan. He was political correspondent for *The Economist* between 1977 and 1979 and then worked for the office of the United Nations High Commissioner for Refugees from 1979 to 1983. After acting as lead international partner at American public relations firm Sawyer-Miller, he was development specialist at the World Bank from 1994 to 1999, administrator of the United Nations Development Programme from 1999 to 2005 and United Nations Deputy Secretary-General from April to December 2006.

Malloch Brown joined the government of Gordon Brown in 2007 at the Foreign and Commonwealth Office and was elevated to the House of Lords as a life peer. After stepping down from the government in 2009 due to family and personal reasons, he was appointed chairman of global affairs for FTI Consulting a year later. In 2014, he was appointed chairman of the board of directors of election technology manufacturer Smartmatic's holding company. In December 2020, he was chosen to serve as president of Open Society Foundations starting in January 2021.
