INTRODUCTION

This booklet has been produced to help with practical information and advice to help those dealing with a bereavement and the procedures and arrangments that follow.

WHEN A DEATH OCCURS

When someone has died, wherever it may be, the Doctor or G.P. will issue a 'Medical Certificate of Cause of Death' within a few hours or days of the death occurring which must be approved by a Medical Examiner.

Providing a registered RGN, District Nurse or Doctor has seen the person after death or has given permission, we are available 24hrs day for an emergency call out to collect your loved one and bring them back to our premises into our care.

WHEN A DEATH OCCURS AND A CORONER IS NOTIFIED

There are some instances, such as a sudden death, where a Doctor may not know or may not be sure of the cause. If this is the case, he or she will inform the Coroner. Depending on the circumstances surrounding a death, the Coroner may order a post mortem examination. If this should happen, we keep in close contact with the Coroner's Officer's, who will inform us & yourselves if there is any need for an inquest or if the post mortem examination has shown that the death was due to natural causes. If the death was due to natural causes, the Coroner will send his equivalent of The Doctor's Cause of Death Certificate to the Registrar in charge of the district where the death occurred.

WHEN A DEATH OCCURS AND A CORONER IS NOTIFIED - CONTINUED.

Once in receipt of this certificate, the Registrar will be able to issue the Certified Copy of The Entry into the Register (Death Certificate). The white form is for Social Services & Form 9 (green form is for burial).

In cases of cremation the coroner will issue the crematorium directly with a Crem 6 (Order for Cremation), this replaces form 9 (green form.) If the death does not show natural causes, for example: Someone has died as the result of a road traffic accident, then there will be an inquest.

In most cases, after the post mortem examination has been carried out the Coroner will open & adjourn the inquest; this is done purely to allow the funeral to go ahead.

At this time the Coroner will issue you an Interim Death Certificate. This can be shown to Banks, Building Societies, Solicitors etc. This certificate officially informs them that the death has occurred.

The Coroner will also issue all documentation needed for the funeral to take place.

The Coroner will also issue you with Original Death Certificates once an Inquest has taken place. Anyone who was shown the Interim Certificate as proof of death will need to see an Original Death Certificate once it has been issued.

CERTIFICATE OF CAUSE OF DEATH

If the medical practitioner who certifies the death is not referring the Medical Cause of Death Certificate (MCCD) to the Coroner, a *Medical Examiner must formally approve the MCCD before the death can be registered.

please do not book to register a death until advised to do so by either - a Medical Examiner's Office or the Coroner (if referred to the Coroner's Office).

From 9 September 2024 it is no longer a requirement to register the death within 5 days of death, but within 5 days of the Medical Examiner's Office or Coroner authorising the registration.

At the point of sending an authorised MCCD to the registration service, the Medical Examiner's Office will contact the family/representative of the deceased to advise them of the need to register the death.

The Registrar will arrange an appointment date and time for you to attend a Regsitration Office. Please allow yourself at least 30 minutes as all the information has to be logged onto a computer & then checked.

A Certificate of 'Registration of Death' (also known as Form BD8 or a Form 344), is a form for social security purposes. Please refer to the notes shown on the back of this form.

A Standard Death Certificate is a Certified Copy of the Entry in the Death Register. These will be required for banks, building societies, solicitors, insurance companies and other financial institutions. The fee for certificates requested on the day of the registration is £12.50 each.

Please note that registrars do not issue a free death certificate as standard.

Often if you produce an original copy of the Death Certificate to the companies mentioned above, they will photocopy the Certificate and return the original. These companies however will not usually accept a photocopy of the original Death Certificate without having seen the original Certificate first.

The Tell Us Once Service is a service that lets you report a death to most government organisations in one go. A registrar will explain this service when you register the death. The registrar will either complete the Tell Us Once Service with you or give you a unique reference number so you can use the service yourself online or by phone.

LifeLedger

Form 9 - The Certificate for Burial or Cremation (also known as the Green Form). This will be sent electronically to the designated Crematorium or Burial Authority (if known) and the Funeral Director.

If in any doubt, please request this form is emailed to our office and we will forward it on where necessary for you.

THE REGISTRAR WILL NEED THE FOLLOWING INFORMATION:

- The date and place of death.
- The full name of the person who has died, as well as any previous or maiden names where appropriate.
- The date and place of birth of the person who has died.
- The occupation and usual address of the person who has died.
- If the person who has died was married or in a civil partnership, the full names, date of birth and occupation of their spouse or civil partner.
- Your name and address.
- If the deceased was receiving any pension or allowance from public funds, other than a state pension, please tell the registration officer.

FORMS REQUIRED FOR CREMATION

Application Form (1)- This form has to be completed & signed by the Applicant. This form grants permission from the next of kin or executor to the Crematorium to allow the cremation to be held.

Form 9 (Green Form for Cremation)~ This form is issued by the Registrar. In addition to the forms listed, every Crematorium has their own forms to confirm the date & time of the service, Hymns, any music & general instructions if known regarding the cremated remains.

If Coroner is involved, they will issue a Form 6 (for Cremation) or burial an Order for Burial.

MEDICAL EXAMINERS

As of **September 2024**, every death will be reported to The Medical Examiner. Medical Examiners are senior medical doctors who are contracted for a number of sessions a week to provide independent scrutiny of the cause of death outside their usual clinical duties.

Medical Examiners are trained in the legal and clinical elements of death certification processes.

MEDICAL EXAMINERS - CONTINUED.

The purpose of the Medical Examiner system is to:

- Provide greater safeguards for the public by ensuring independent scrutiny of all non-coronial deaths.
- Ensure the appropriate direction of deaths to the coroner.
- Provide a better service for the bereaved and an opportunity for them to raise any concerns to a doctor not involved in the care of the deceased.
- Improve the quality of death certification.
- Improve the quality of mortality data.

SOCIAL FUND

If the person arranging a funeral is claiming Benefits or Tax Credits, you may be eligible for help paying the funeral costs.

PROBATE

When a person dies, somebody has to deal with their estate (the money, property and possessions that they owned) by collecting the assets together, paying funeral expenses, debts and distributing what is left to the people entitled to it.

To ensure that this happens properly according to the appropriate laws and to limit the responsibility of organisations holding assets (banks, building societies, insurance companies etc), the Court issues a 'Grant of Representation', commonly known as 'Probate'.

The current threshold for an estate is £325,000. For any estate over the threshold, tax is charged at 40%.


