

UTV Terms and Conditions

Agreement between User and Urbn-tv.com

Welcome to Urbn-tv.com. The Urbn-tv.com website (the "Site") is comprised of various web pages operated by Urbn TV ("UTV"). Urbn-tv.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of Urbn-tv.com constitutes your agreement to all such Terms. Please read these terms carefully and keep a copy of them for your reference.

Urbn-tv.com is a Video Media Site.

Urbn TV provides an online video service that gives users the opportunity to select from various offerings of live and on-demand programming, including movies, television shows, clips, and other content (collectively, the "Content"). Our video service, the Content and any other products, features, tools, materials, or other services offered from time to time by Urbn-TV through a variety of Access Points (defined below) are referred to collectively as the "Services". The term "Access Points" refers to, collectively the Urbn-tv.com website, applications, and other places where any Services are available, including websites like our affiliate distribution partner, ROKU Inc., where our Services are offered in cooperation or connection therewith and whose (ROKU) terms of use and service are incorporated by reference herein. This Terms of Use Agreement ("Agreement") applies whether you are accessing the Application via a personal computer, a mobile device, or any other technology or devices now known or hereafter developed or discovered (each, a "Device"). this Agreement governs only the content, features, and activities related to the Applications and does not cover websites or applications for any other programming channel or affiliates of Urbn-TV, or any other company unless specifically stated. in this Agreement, the term "Applications" includes all websites and web pages within or associated with the Applications as well as any equivalent, mirror, replacement, substitute, or backup websites and web pages that are associated with the Applications. By using any Application, you understand, acknowledge and agree that you will abide by the terms of this Agreement and any additional terms that govern certain products and/or services, which will be presented in conjunction with those products and services {"Additional Terms"). This Agreement will remain in full force and effect as long as you are a user of the Application and in the event of termination of any membership, service or feature related to this Application, you will still be bound by your obligations under this Agreement, the Privacy Policy, any Additional Terms of Rules, including, without limitation, any indemnifications, warranties and limitations of liability.

The words “use” or “using” in this Agreement means any time an individual (a “user”), directly or indirectly, with or without the aid of a machine or Device, does or attempts to access, interact with, use, display, view, print or copy from the Application, transmit, receive or exchange data or communicate with the Application, or in any way utilizes, benefits, takes advantage of or interacts with any function, service or feature of the Application, for any purpose whatsoever. This Agreement does not cover your rights or responsibilities with respect to third party content or sites or any links that may direct your browser or your connection to third party sites or pages.

Privacy

Your use of Urbn-tv.com is subject to UTV's Privacy Policy. Please review our Privacy Policy, which also governs the Site and informs users of our data collection practices.

Electronic Communications

Visiting Urbn-tv.com or sending emails to UTV constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

Your Account

If you use this site, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. You may not assign or otherwise transfer your account to any other person or entity. You acknowledge that UTV is not responsible for third party access to your account that results from theft or misappropriation of your account. No Unlawful or Prohibited Use/Intellectual Property

You are granted a non-exclusive, non-transferable, revocable license to access and use Urbn-tv.com strictly in accordance with these terms of use. As a condition of your use of the Site, you warrant to UTV that you will not use the Site for any purpose that is unlawful or prohibited by these Terms. Use of Communication Services

International Users

The Service is controlled, operated and administered by UTV from our offices within the USA. If you access the Service from a location outside the USA, you are responsible for compliance with all local laws. You agree that you will not use the UTV Content accessed through Urbn-tv.com in any country or in any manner prohibited by any applicable laws, restrictions or regulations.

Indemnification

You agree to indemnify, defend and hold harmless UTV, its officers, directors, employees, agents and third parties, for any losses, costs, liabilities and expenses (including reasonable attorney's fees) relating to or arising out of your use of or inability to use the Site or services, any user postings made by you, your violation of any terms of this Agreement or your violation of any rights of a third party, or your violation of any applicable laws, rules or regulations. UTV reserves the right, at its own cost, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you, in which event you will fully cooperate with UTV in asserting any available defenses.

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and UTV agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
