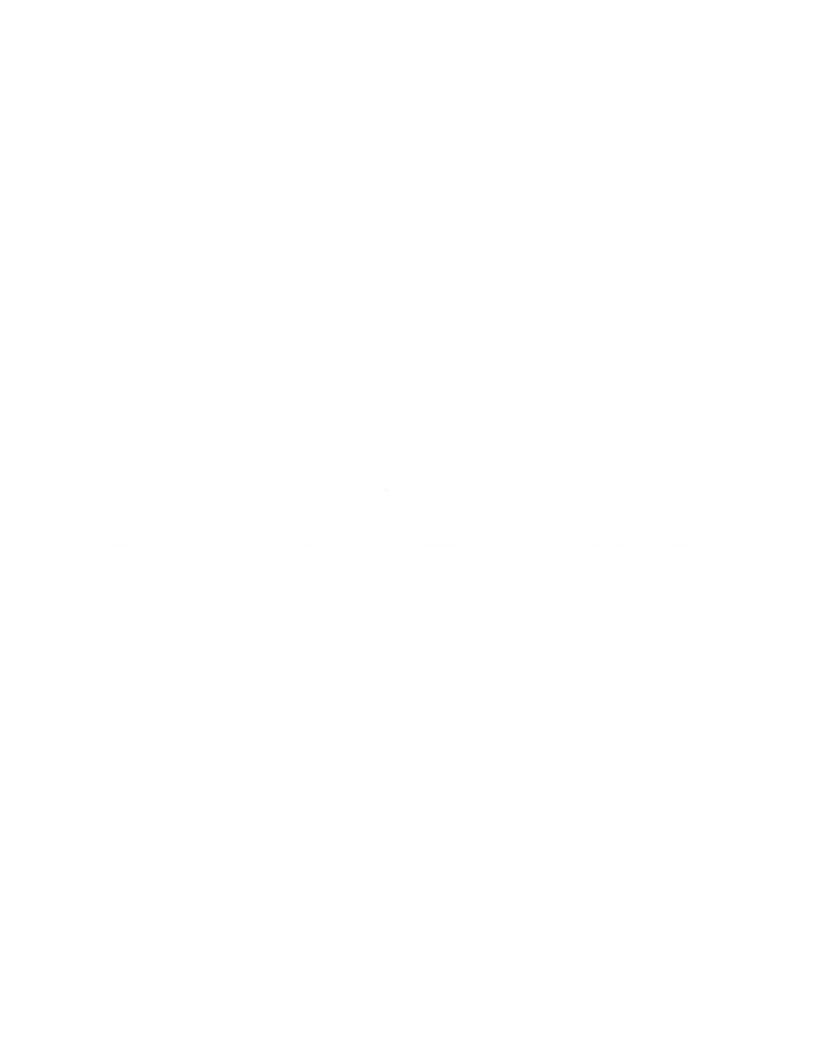

2021 Treasurer's Report

In 2021, the Finance Committee met monthly to review income and expenses along with making decisions about timing payments with times of increased giving to meet obligations.

We did not meet the proposed income budget and our expenses exceeded our income most months. In March, \$10,000 was taken from Edward Jones Investments and added to the general fund; an additional \$7,400 was taken in September. Redeemer has had the Edward Jones account since 2014, when an estate was given to the church. Since that time, a few members have contributed stocks to the church through this account to be used as part of their yearly offering commitments. Some additional offerings were collected following the letter Faith & Family Stewardship Committee mailed to members.

The bill for shingling the roof was paid in July. The finance committee is very grateful for and sincerely thanks the congregation for exceeding the \$15,000 goal to this special fund.

We were able to meet the Synod's (\$15,000) and Pathways (\$3000) giving commitment for the year.

It is worth noting that no funds had to be borrowed or used from another form of savings, and the year ended with a positive balance! Thank you, members of Redeemer, for stepping up with financial support during this difficult year.

Looking forward to 2022, there will be expenses related to the call of a Rostered Pastor. The property committee has a list of projects that need to be completed such as removing and recaulking all the classroom windows.

Re: Review 2021 financial records

The financial oversight committee and Marit Martell, the financial secretary, have been communicating via email for the past two weeks reviewing the processes, account balances, and any process changes that occurred in 2021.

Accounting System-The financial printed reports are user friendly and understandable. The checks and balance system of counting the deposits was still slightly altered this year because of COVID-19, but for the most part has gone back to normal. Again in 2021, most of the deposits were made by direct payment or checks, although envelop offerings from in person worship did increase as the year went on. Cash Basket offerings in 2020 were around \$1,800 and in 2021 it was just over \$6,300.

Budget – As of the end of December 2021, Redeemer Lutheran Church had a cash balance of \$25,782 in the checking account. The projected expenses for the 2022 fiscal year are \$237,708 (around a 20% decrease from the 2021 fiscal year). With only having enough money in the checking account to cover just over one month's worth of bills Marit is nervous that at some point this year we will not have enough money to cover all the expenses for the month. We had to dip into the cash available in the Edward Jones Investment account during the year to be able to pay bills. With that cash inflow from the Edward Jones account, the actual revenue was \$1,999 more than the actual expenditures for the 2021 fiscal year which is a large improvement over the loss experienced in the 2020 fiscal year. One contributing factor to that is the loss of our youth director, Madison. She left at the end of August. The other reason for the decreased loss is the transfer in of the mentioned liquid cash of \$17,400 in the Edward Jones Investment Account.

Cash receipts – Collections are safeguarded by using locking deposit bags and night bank depository until picked up and counted. There are always two people to count the weekly deposits. Deposit slips are attached to weekly summary verification sheets. Verification sheets are retained and reconciled with actual deposits. Weekly tithes and offerings are usually paid the following way: Vanco, EFT, remaining congregation offering plate (checks and cash).

Cash disbursements – Payments are properly approved, recorded and supported by appropriate documentation and filed in paid-invoice files with check stubs stapled to the paid invoice. All checks require two signatures. There is no petty cash to account for.

There is one credit card, which is kept in the church office. The financial secretary said that for the most part, the charges are turned in with good documentation. We recommend that for anyone using the credit card, to please turn in a receipt in a timely manner with a description of what was purchased and what expense code should be used to make payment.

Journal – Most journal entries are for electronic payments. Payment confirmations are included with the journal entries for these payments.

Investments – Mission Endowment Fund is handled by a separate committee reporting to the church council.

We are very satisfied with how the records are being kept and submitted

Council President's Annual Report

Following the January annual meeting, officers and committee representatives were chosen. New members were installed at a later date.

The Redeemer Church Council met regularly on the third Tuesday of each month. The minutes of each meeting were posted in the church newsletter.

Throughout the year, we continued to meet the challenges of the pandemic. At the beginning of the year, we met in the sanctuary so that we could social distance and wear masks during our meetings.

our February retreat for new council members was postponed until March because of the weather. We heard about each committees responsibilities and goals

In May we received a letter from Pastor Darrel Cory, that after much prayer and discussion with colleagues, he would be retiring at the end of 2021. We are thankful for your service among us, Pr. Darrel, and we will treasure the remainder of the time we'll spend together. For the first time, Synod Assembly was held virtually. Myron and Juneal Peterson, Pr. Darrel and I attended the May 22nd event. I was so glad to have Jan Anderson in attendance to help me read the screen and to vote virtually. We were blessed with inspiring worship services, encouragement from synod leaders, and opportunities to serve our brothers and sisters In need.

Earlier in the year, the council chose to sponsor a blood drive, and worked very hard to secure volunteers to call donors, to provide and serve snacks, to register donors, and to be in constant contact with Vitalant. Some council members and others from the congregation stepped up to the plate to help. The event itself was on two very hot days—June 8 and 9, and we scrambled to find more fans. The event was a success, and when we sponsor another blood drive, we will need more council members to participate. Thank you to all who helped and all who donated blood products.

In late June and July, we supported a Northwestern Minnesota Synod project, helping our companion Synod The Andrha Evangelical Lutheran Church of India to bring relief to those struggling with the devastation of COVID-19, esp. those who are homeless, and assisting Lutheran World Relief with supplies for those who'd lost everything in floods along the border between India and Indonesia. Instead of choosing one Sunday for a special offering, we chose to extend that offering opportunity for a whole month. Thank you for supporting this mission event.

In August, we accepted the resignation of our youth director Madison Crane, whom we shared with Zion. We thanked Madison for her hard work and wished her well in her new adventures. Her last day was August 25. The position remains vacant and will need to be reorganized, perhaps among Redeemer, Zion and Trinity, before we can move forward to fill it. On September 12, following an out-door worship service, council members and committees participated in hosting the Redeemer Church Expo once again. We prepared for at least a week by decorating tables, gathering information to share with the congregation, collecting prizes, and otherwise creatively advertising the event. At this event, the congregation learned about

each committee and about the council, participated in drawings for prizes, and enjoyed rolls and coffee. At our September meeting, Jan Anderson was in attendance to explain the updates to Redeemer's Constitution. Many of the changes were due to the changes in the ELCA's own Constitution. Updates will be made at the annual meeting.

In November we received the 2022 budget plan to study and to adjust for discussion in December. Following our discussion, we'll approve the budget that will be recommended at the Annual meeting.

We appreciate all of the committees and their hard work to keep our ministries strong. Thank you for submitting your reports regularly throughout the year. We're stronger when we work together, and when we communicate with each other frequently. Redeemer Congregation, no question to your council is ever a stupid question. Please continue to share your thoughts with us, and please lift up our leadership in prayer.

2021 ANNUAL REPORT

The mission of the fund is to enhance the mission outreach of the Church apart from the general operation of the congregation. The fund may use the income from its investments for: Community and synod outreach; missions of the Church at large; capital improvements at Redeemer; and new programs, projects and outreach at Redeemer.

The Fund's investments performed well again in 2021. Interest income and market gains exceeded **16%**. Grants of \$20,056 were made during the year to the ELCA Good Gifts program, Thief River Falls Area Food Shelf, Violence Intervention Project, Northern Minnesota ELCA Synod, Hospice and Pathways.

Applications for grants are received and reviewed by the Committee quarterly or as needed. If you are interested in receiving a grant from the Fund, please contact a Committee member or the Church office for an application form.

2021 Annual Report from the Faith & Family Stewardship Committee

At the beginning of the year, the Stewardship Committee and Faith, Family Fellowship Committee were combined to form the new Faith & Family Stewardship committee. A combined committee policy and mission statement were developed. All Redeemer members are called to be stewards of God's love, to care for and support one another.

The Faith & Family Stewardship Committee purpose statement says: Stewardship is the belief that followers of Jesus are responsible for the earth and should take care of it. Stewardship applies to our whole life, recognizing that ALL we have is a gift from God, ALL we have belongs to God, and ALL we have is to be used to serve God and enjoy God's blessings. **Stewardship is everything we do after we say, "I Believe."**

As a way to welcome families back to in person worship, simple meals such as Supper in a Sack and Box Brunch, were served following outside worship services. A scaled back Block Party returned in August. Yard games were played, and grilled hot dogs served. Paula, Greg, Dean, Chris & Terri provided great music.

Redeemer's Fall EXPO returned in September. Committees displayed information and treats, several door prizes were donated and given out to attendees.

The Meals on Wheels Stewardship will continue in 2022. Thank You to the volunteer drivers that sign up to deliver hot meals to people not able to get out or are unable to prepare a meal. Redeemer will deliver meals in February, May, and October.

On Mission Sunday, Faith & Family Stewardship joined efforts with Evangelism & Social Ministry to focus on Foster Care. Thank you, Gary Hintz, for sharing your family's journey with the Foster Care Program.

In December we celebrated a worship service and catered lunch with Bishop Tesch.

Celebrate Generosity was the theme of the fall stewardship drive. Moments for Mission reminded us that giving is an act of worship, financial giving needs to be consistent and in proportion to income. Financial giving needs to be prayed about and planned in advance.

The most common thought when hearing the word Stewardship is money. However, it is important to remember that as members of Redeemer, we are to be generous with time, talent, and money. God's work, our hands. Members are asked to complete an Estimate of Giving card and a Time & Talent sheet and return to the church or place in the offering plate. Worship participation, involvement and financial giving have been lagging since the pandemic stopped in person worship for several months.

- 26 Estimate of Giving Cards were returned with a total \$82,216.00 pledged
- 19 Time & talent sheets were returned.

Thank you for your faithful support as we have been transitioning back to in person worship and activities. Prayerfully consider increasing weekly worship attendance, your time in serving others through committees, serving on church council, teaching, quilting, alter guild, working with youth, choir and or other music talent, etc. Pray about increasing your weekly offering in 2022. Giving of self, time and money must continue if Redeemer is to continue doing God's work, not only in Thief River Falls, but throughout the state, nation, and world.

Altar Guild Annual Report - 2021

The Altar Guild of Redeemer Lutheran Church typically meets the last Tuesday of the month at 6:30 in the Emmaus room. Due to Covid many of our meetings this year took place via Zoom. But we are back to meeting in person now that Covid restrictions have been eased. Our meetings follow an agenda that includes brief devotions, a report from the pastor, new and old business, and worship plans for each month. Members sign up for weekly/monthly duties. These duties/responsibilities include:

- Preparing the Altar for service (dusting the Altar and pulpit, cleaning, changing and replacement of Altar cloths/linens, paraments, banners; maintenance and replacement of candles and candle oil; maintenance of Altar fixtures, inventory and purchase of Altar supplies)

Evangelism & Social Ministry Committee: 2021 Annual Report

The focus of the Evangelism-Social Ministry Committee is outreach and we have had a busy year!

Our first event of the year was the *Sock Drive* in April and May. We received donations of 348 pairs of socks that were distributed between the Violence Intervention Project in Thief River Falls and the Northland Rescue Mission in Grand Forks.

Our committee, in concert with the Redeemer Council, coordinated a *Vitalant Blood Drive* in June which was well-attended and provided much-needed blood donations to the area blood bank.

We sponsored the *Back to School Blitz* collection event in July and August, after which we were able to supply a large assortment of school supplies to the Violence Intervention Project for use at their discretion, and as their clients' needs arise.

We also sponsored the "virtual" *Hospice Spaghetti Dinner*. The 2021 event was again supported by monetary gifts from Redeemer members and the community at large. The total amount collected from individuals, the Redeemer Mission Endowment Fund, and local organizations totaled \$2,527.00, which was sent to Hospice of the Red River Valley.

In November, we collected items for "Foster Care Bags". Gary Hintz, a member of the Redeemer Council and the Evangelism-Social Ministry Committee, gave a talk highlighting needs for children placed in foster care. He is a foster parent and gave great insights into the needs of that program. Of course, Redeemer, you responded in your typical "more-than-generous" fashion. There were 327 items/packages of items donated from nail clippers and deodorant to diapers, underwear, pajamas, toiletries and shoes. You are awesome!

In November and December, we sponsored the "Good Gifts for Christmas" event. The designated gifts were purchased through the ELCA Church-at-large for distribution to communities throughout the world. The Good Gifts event is our ultimate "outreach" effort. The total amount of purchases included \$2,985 from individuals/families of Redeemer plus an additional \$5,000 from the church endowment fund. Thank you, once again, for your giving spirit and participation!

We were without the participation of the Redeemer Youth this year due to the vacancy in the position of youth director, but we hope to bring back the *BARNYARD BLITZ* in December 2022! Members of Redeemer – you may have herds of animals in your yards in December 2022, so get your troughs and water tanks ready – or at least your donations and names of friends you'd like to "blitz"!

Throughout the year, the *visitation group* typically goes to shut-ins and homebound members offering communion and a friendly visit. This year, the visits have been by phone, and those requesting communion have contacted the church office and the Pastor has visited them when able.

Thank you, Redeemer, for readily supporting each and every one of the events. You are the best!

The Faith Formation Committee operates under the following mission statement: Implement, evaluate, and improve the youth education programs of Redeemer Lutheran Church in order to enrich the faith formation of our youth members/attendees.

This committee continues to show their support and guidance with the confirmation program which has now transitioned to a format of starting in the 6th grade and concluding with Confirmation (affirmation of baptism) in the fall of the 9th grade year. Confirmation classes are held for 6th and 7th graders. The 8th grade confirmation year consists of class lessons as well as service opportunities.

Our BLAST (Bible Learning and Serving Together) program resumed in-person classes this fall and is held every Wednesday at 5:45 in the sanctuary and includes music/sing-along with Reid followed by classroom lessons with our BLAST teachers.

This year we had our Christmas program in person and our families loved it. BLAST kids sang a few songs and shared an alphabet poem reading of the Christmas story. We also had a few of our confirmation students helping with reading and greeting.

This past summer, we could not afford our regular VBS week with Pathways. Madison was able to get some curriculum and put together a VBS week that took place in the evenings. It was well attended.

While this has been an unusual and trying time for all of us, we are blessed to be back to gathering in person and serving together in whatever capacity we can.

As a committee, we continue to evaluate programs, take suggestions, and make adjustments to fit the educational needs of the members of our congregation. We appreciate any feedback from the congregation as we continue to look for ways to improve and keep families invested and involved.

Redeemer Lutheran Church Property Committee Annual Report 2021

The Redeemer Property Committee members are: Pastor Darrel Cory, Cecil Anderson, Al Johnson, Nathan Pray, Jason Schuster, Lynn Teie, Gary Tischer and Council Member Wenda Sang.

- 1. The biggest project during this year was the reshingling of the two roofs of the west and east wings and the roof of the Fellowship Hall. Mid-west Roofing and Siding Company (Gary Senum owner), Thief River Falls, MN was the contractor. Start date was May 10, 2021 and end date was June 15. The three tab shingles were replaced with Certainseed Landmark Laminated Burnt Sienna colored lifetime shingles. Shingles and other materials cost \$18,208.12. Labor cost was \$20,365.00. City Building Permit cost was \$789.14. Total cost for this project was \$39,362.26. A congregation church fund raiser for this project raised \$20,000.00. Thanks to all who donated to fund this project. Thief River Falls City Building Inspector Greg Hufnagel and Gary Tischer inspected the shingling project.
- 2. The choir, old library and the music office rooms were carpeted with gray 24 inch by 24 inch squares of carpet. The squares are glued down to the existing tile flooring. The carpet was purchased from Hazel Blue Furniture/Five Star Flooring (Stacy and Sean Myhrer, Thief River Falls). They charged the church \$2,825.72 which was a reduced price from their original bid. The walls were also painted in the old library before the old carpet was removed. Cecil Anderson and Reid Froiland installed the new carpet. Reid painted the old library walls before the old carpet was removed.
- 3. The heating boilers were serviced in February and April by Brodin Sheet Metal but problems still existed. Austin Beito from Beito Heating and Plumbing, who helped install the new boilers, was hired to service the boilers and radiators in October. After he serviced the boilers the two boilers were working but not properly so on December 28 and 29 Austin worked on the system finding out that two of the five circulating pumps were not circulating hot water to two areas of the church. Two new circulating pumps were installed and the hot water lines were bled to remove all air from the water lines. As of this report the boiler system is working properly. A total of \$5,030.00 was spent on getting the boiler system and radiators in running condition.
- 4. Parking lot stripes and handicap symbols were painted directing people to proper parking spots.
- 5. New LED light bulbs were installed in the front high part of the Sanctuary in July by electrician Jeremy Snrsky and several committee members. These were the last of the LED bulbs to be replaced in the Sanctuary. The bucket lift was rented from Ace Rental to reach to the top of the ceiling.
- 6. Patio area exterior electrical outlets were installed on the south side of the church building to accommodate plugging in of musical intruments and microphones when outdoor services are held. Jeremy Snrsky, electrician, completed this project.
- 7. Seven yards of black soil were used to fill 60 holes in the lawn area. Jeff Olson, Olson Construction, Thief River Falls, donated the black soil. Several members of the committee

distributed the soil into the holes. Grass seed was planted on the soil.

- 8. Three trees were cut down and stumps were ground out and black soil was used to fill the holes. Contractor D and K Tree and Stump Removal, Thief River Falls, was hired to complete this project.
- 9. Low hanging branches were cut off by committee members from some of the trees on the north and east sides of the church so that the lawn mower contractor did not have to continually get hit by the branches.
- 10. Rain gutters were cleaned out removing shingle pieces, shingle rock dust and small branches and tree leaves where necessary by committee members to allow better water flow off the roofs.
- 11. Committee members put up and took down the Christmas Nativity display.
- 12. Vegetation was hand pulled or chemically sprayed in the rock areas, sidewalks and tarred parking lots.
- 13. The lawn mower contractor and side walk snow removal contractor, Ashton's Lawn Mower and Snow Removal Service, was hired and overlooked by the committee.
- 14. The parking lot snow removal contractor, Olson Construction, was hired and overlooked by the committee.
- 15. Cleaned several ceiling light covers of bugs and dirt and replaced light bulbs.
- 16. Reviewed the west and east entrance exterior wall lights to determine what needs to be done to make the east lights to properly work and to install new fluorescent light fixtures on the west wall.
- 17. An inquiry was made by a church member asking if a donation could be made for planting a tree in the church lawn in honor of a person. This is being looked at by the committee.
- 18. An insurance inspector from Redeemer's Church insurance company, Loeffler Insurance Agency, inspected the entire church building. There are no fire alarms nor smoke detectors in the church.
- 19. All air conditioners were looked after.
- 20. Curbs, parking lot edges and the east sidewalk were marked with reflectors for the snow removal contractors.
- 21. Many miscellaneous projects were completed that are to numerous to mention.

Mission Support from congregations in the Northwestern Minnesota Synod over the past year helped to accomplish the work of our ministry together:

- Synod Ministers for Community and Leader Engagement provided over 2,200 hours of "boots on the ground" support for leaders and communities this past year.
- Responded to the COVID-19 crisis with resiliency and encouragement grants to numerous congregations, rostered ministers, lay staff and seminary students totaling over \$36,000.
- Supported new worshipping communities among neighbors struggling with homelessness in the Moorhead area, and among the young and Indigenous neighbors in the Bemidji area.
- Hosted monthly Zoom meetings for rostered ministers, those working with First Third of Life ministry, and council presidents, offering support and resources.
- Accompanied 32 rostered ministers and SAMs to their call to serve in congregations, parishes, care centers, and outreach ministry across our Synod.
- Entranced and accompanied seven rostered minister candidates this past year and supported 17 rostered ministers in their first call through First Call Theological Education.
- Supported the Native Neighbors Table and the work of our Synod's Commission on Racial Equity and Justice and the LGBTQ+ Accompaniment Team.
- Coached leaders trained in our Synod's Practicing Resurrection: Experiencing Vitality process, and are training the next cohort of leaders who started this journey in October.
- Equipped and encouraged lay leadership through LIFE Living in Faith Everyday (formerly known as the School for Lay Ministry).
- Provided guidance and support to rostered ministers and congregations in a conflict situation.
- Attended to congregations entering a call process by assisting in arranging for an interim pastor, orienting call committees and providing a new user-friendly call process manual.
- Welcomed SAMs to a new and improved support system managed by SAM Kathy Levenhagen.
- Provided resources (e.g. worship, sermons, COVID-19 guidance, stewardship, etc.) through our Synod's robust social media presence.
- Facilitated area strategies in the Roseau, Crookston, and Alexandria Conferences.
- Started five topic-based cohorts for rostered ministers and SAMs, led by an executive coach.

Dear Partners in God's Mission,

I am writing this message for your congregation's annual report just as a new year is dawning in our church's liturgical calendar — it's the week of Thanksgiving, and this Sunday will be the first Sunday of Advent. It's been another hard year with COVID-19 infections still surging, continued political unrest and persistent economic uncertainty. Our natural inclination in such times is to hunker down, but Jesus taught otherwise. To his followers facing disturbing times, Jesus' counsel is, "Stand up and raise your heads, because your redemption is drawing near." (Luke 21:28). If Jesus' words were intended only for the end of all things, then they would have been of little use to his followers when he first spoke them, or to anyone over the last 2000 years. So, let's hear them in the way Jesus intends them - to meet us right here in the middle of <u>our</u> turmoil.

I hear in these words the promise that Christ our Lord will be present in the messiness of troubling times. I also hear an admonition to stand up and take notice of what Jesus is up to around here! I believe that when you lift your heads to see what Jesus is up to in your community, you will see a lot. Here's what I can see:

- Jesus is showing up where he always has, and he is teaching us that this is enough. We do not have the solution to our political divisions or our public health emergencies. We only have the saving good news of God's love for every person through Jesus Christ, and Christ's presence with us in the word and the sacraments. One motto we could take away from this era of diminished programming is "Less effort. More Jesus." Jesus is freeing us to set aside all that does not pertain to sharing the Gospel, celebrating the sacraments and loving our neighbors.
- Jesus is not letting us off the hook he is continually turning our eyes toward his suffering beloved: from the parent of a black child who is terrified for their safety each time they go out in public, to the farmer at her kitchen table despairing over yet another failed crop. In former times we might have averted our gaze, but now we cannot look away. When we finally see the neighbor as <u>our</u> neighbor, then our collective redemption really is drawing near.
- Synod are engaging new people through their online worship and ministries. New people will not walk into your church unless they have an invitation directly from you. Church buildings are no longer seen as public, but as private spaces only for the invited. The new public space is online: no invitation necessary drop in anytime. The Gospel can be heard just as clearly from Facebook as it can from inside our buildings. Our challenge as the church of the 21st century will be to bring together our inperson and our online people to build communities with living connections of friendship and support.

And I am grateful for you because I see Jesus at work in you: in your continued faithfulness to him and in your continued generosity that fuels the ministry of the Gospel both in your own congregation and, through your mission support, across our Synod and around the world. Thanks to you, we are making good progress on the four strategic initiatives (see attached) that you affirmed in our strategic plan at the 2021 Synod Assembly. During the week of November 18, you gave over \$60,000 to our GiveMN Give to the Max campaign, which launched "Leadership Next" for recruiting and forming adaptive leaders who are servants of Jesus Christ. As of this writing, Mission Support from congregations is running 4.2% ahead of last year. If that trend continues, we will meet the ambitions plan that you approved for this fiscal year.

In the midst of the extraordinary challenges of these times, we have a great good Lord who does not hover safely above it all, but who is down in the mess with us - loving all people and calling them to believe the Gospel. Join me in lifting your head to see Christ at work in your community and in our world.
