Salaries to employees and allowances to members were paid in accordance with this authority's approvals, and PAYE and NI requirements were properly applied	It was not possible to reconcile the P60 to the cashbook and the figure on the AGAR Section 2 Accounting Statement but I understand there were issues with the payroll software during the year. Recommendation: consider outsourcing the payroll as it is not expensive and reduces risks to council and clerk
