1259 Election of the Chairman

The Clerk asked Councillor Sadler if he would be prepared to stand as Chairman again, he agreed, nobody else wished to stand. Councillor Owencroft nominated him, and Councillor Prosser seconded him, Councillor Sadler was elected as Chairman.

1260 Election of Vice Chairman

1261 Roles and Responsibilities

1262 Chairman's overview of the year

The Chairman gave an overview of the key items in 2021/22, these included:

- The purchase of a new Speed Indication Device n partnership with Candover Parish Council
- Parish Council meetings returned to face-to-face following the pandemic
- The defibrillator was taken but was not required by a local resident
- A survey of all trees was conducted
- A meeting was held with the school and District and County Councillors to discuss speeding and traffic calming
- Southern Water held an open day to discuss the Drought Scheme requiring water to be pumped from a bore hole in Preston Candover to Southampton during periods of extreme drought

- Work was carried out to clear ditches in the Autumn
- The contract for electricity for the streetlights was renegotiated
- Preston Farms presented plans for a solar farm

1263 Annual Accounts

The Annual accounts were Internally Audited on 27th April and the Clerk informed Councillors that there were three actions:

- Risk Assessment Though you have a drafted Risk Assessment this needs to be approved by Full Council
- Asset Register Thank you for the up-to-date Asset Register. The draft AGAR needs to be amended to reflect these figures.
- Accessibility Statement IO note this is in draft format and will be presented to Council for agreement.

The Clerk to add the Risk Assessment and Accessibility Statement to the next agenda for approval.

The Council signed off by the Parish Council following the Annual Governance Statement being agreed.
