About The Company

Danceline LA's Pre Professional Dance Company consists of dancers ranging in ages from 8 to 18. The Company offers aspiring students the opportunity to train, grow, and perform multiple styles of dance in the community as well as in professional theaters. Company members have the opportunity to train in Ballet, Jazz, and Hip Hop. Our goal is to develop well rounded dancers, as well as build a positive environment to encourage self esteem, discipline and teamwork.

Participation Requirements

Levels in the Company will vary according to ability, age, and dedication; therefore it is necessary for students to study in their required technical classes to ensure proper growth and development. Each dancer who auditions will be placed in their appropriate level, and are required to take the designated classes for each portion of the Company they will be performing in.

Attendance in rehearsals is extremely important. Dancers will be learning choreography, practicing performance skills and learning formations for specific routines. If a dancer needs to miss a rehearsal an email **MUST** be sent to info@dancelinela.com excusing them from practice. If a dancer misses too many rehearsals Danceline LA has the right to pull them from any performance.

Attire/Dress Code

Following Dress Code is imperative and a **MUST**, as it affects a dancers ability to learn and develop proper technique. Danceline LA is not only training dancers on a technical level, but also helping our students learn how to come prepared for any event that may occur in life. Not following dress code may result in a student being excused from class/rehearsal.
