#### Proposed Amendments that require your vote (proposed changes are identified in blue)

##### JHR 121

Amending qualifications to become a Texian

Section 6: Every living soul who shall have achieved the age of 18 years and be native born with verifiable parentage by common law to the land of the republic of Texas and maintained a domicile for one year immediately preceding declaration as Texian National and, additionally, those who have lawfully immigrated to the same from English-speaking American nation states after having a lawful domicile within the borders of the republic of Texas for three years and those that have lawfully immigrated to the same from international nations and territories after having a lawful domicile within the borders of the same for five years shall make an oath by law before a competent authority that they intend to domicile in the republic of Texas and shall swear to support its Constitution bearing true allegiance to the same and, accordingly, shall be a Texian National possessing all rights and responsibilities as described and sealed forever in the peoples' Declaration of Rights. ##### JHR 122

[Amendment to Article I Sec 6](#)

The house of representatives shall choose their speaker, **who shall have actively served at least one term in Congress** and other officers, and shall have the sole power of impeachment. [Constitution 1836 \(therepublicoftexas1836.org\)](http://therepublicoftexas1836.org)

#### **JHR 124**

##### **Amendment to Article III Sec 2**

The first president elected by the people shall hold his office for the term of two years, and shall be ineligible during the next succeeding term; and all subsequent presidents shall be elected for three years, and shall be **eligible to serve no more than two consecutive terms**; and in the event of a tie, the house of representatives shall determine between the two highest candidates by a viva-voce vote. #### **JHR 125**

##### **Amendment to Article I Sec 3**

The members of the house of representatives shall be chosen annually, on the first Monday of September each year, until congress shall otherwise provide by law, and shall hold their offices for a term of two years from the date of their election. **wherein the house of representatives shall be divided into two classes, as nearly equal as practicable, the seats of the representatives of the first class being vacated at the end of the first year; and representatives of the second class being vacated at the end of the second year, in such a manner that one-half of the representatives shall be chosen each year.** [Constitution 1836 \(therepublicoftexas1836.org\)](http://therepublicoftexas1836.org)

#### **JHR 126**

##### **Amendment to Article I Sec 4**

No person shall be eligible to a seat in the house of representatives until having attained the age of twenty-five years, shall be a **Texian national of the republic of Texas for “one” year for being native born of Texian parentage, a Texian national of the republic for “two” years for people immigrating from any English-speaking American nation state or territory or a Texian national of the republic for “seven” years for people immigrating from international countries, and shall have domiciled in the county or district six months next preceding their election.** [Constitution 1836 \(therepublicoftexas1836.org\)](http://therepublicoftexas1836.org)

#### **JHR 127**

##### **Amendment to Article I Sec 5**

The house of representatives shall not consist of less than twenty-four, nor more than forty members, until the population shall amount to one hundred thousand souls, after which time the whole number of representatives shall not be less than forty, nor more than one hundred provided, however, **“until” each county is represented, the house of representatives is authorized to conduct business, and that each county shall be entitled to at least one representative.** [Constitution 1836 \(therepublicoftexas1836.org\)](http://therepublicoftexas1836.org)

#### **JHR 129**

##### **Amendment to Article VI Sec 1**

No person shall be eligible to the office of president who shall not have attained the age of thirty-five years, shall be a citizen of the republic at the time of the adoption of this constitution, or an inhabitant of this republic at least three years immediately preceding his election.

As Amended by Amendment Article VI, Sec. 1:

**“Eligibility for the office of president of the republic of Texas includes having attained the age of thirty-five years, a Texian national within the republic of Texas and domiciled within Texas for at least seven years immediately preceding election to office.”** [Constitution 1836 \(therepublicoftexas1836.org\)](http://therepublicoftexas1836.org)
