

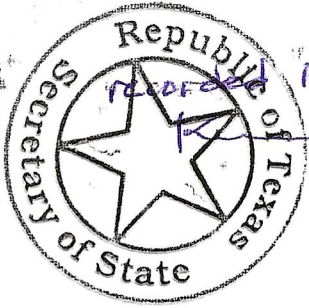

LAW OF THE TEXIAN PEOPLE

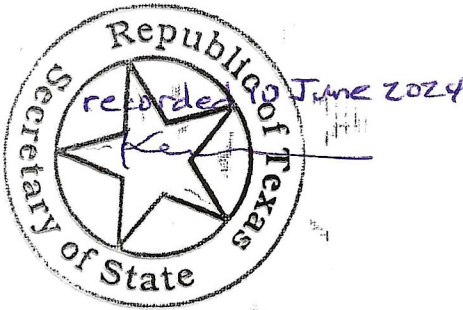
Congress and or official government are to be surrendered. This is the right of the Texian people to preserve history.

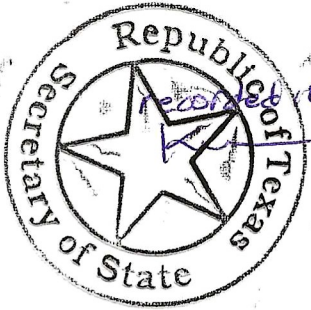

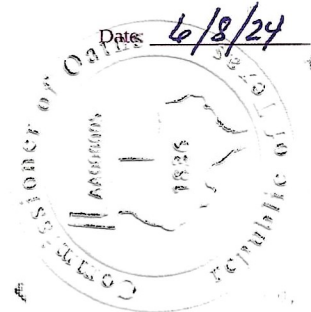
