

APPLICATION FOR TEXIAN ID CARD Checklist

When filling in your **Texian ID CARD APPLICATION** you must complete the following:

- ☐ First fill out the “APPLICATION FOR TEXIAN ID CARD” form
- ☐ **You must select one of the three choices** in paragraph two (2) or renewal
- ☐ A **colored copy** of the application must be completed.
- ☐ Place a **red ink thumbprint** above **My seal - Right Thumb Print (Red Ink)** on form
- ☐ ID cards require a digital image of yourself. A phone image is acceptable if you do not have a digital camera. The image should be a quality head shot, similar to a passport photo. Use an uncluttered, plain, light-colored background. No hats, caps or glasses. This will be the image that will appear on your card for the next 5 years. It's okay to smile!
- ☐ Send the digital photo to sos@therepublicoftexas1836.com.
- ☐ There is a charge of \$40.00 for the ID card to cover the costs incurred. If sending a **check** or **money order**, make payable to: SOS Mary Reichardt.
- ☐ The ID card is valid for 5 years.
- ☐ If your card is lost, stolen, needs replacement, or renewal there is a cost of \$25.00 for the replacement card.
- ☐ If you come to one of these meetings you may also pay for your ID card with one and 1/2 oz of silver instead of \$40.00. I wouldn't recommend mailing silver but it has been done and you can. We also accept federal reserve notes.
- ☐ Also, an AFFIDAVIT OF FACTS AS A TEXIAN form is also required which can be found under this same tab.
