	background. No hats, caps or glasses. This will be the image that will appear
	on your card for the next 5 years. It's okay to smile!
	Send the digital photo to sos@therepublicoftexas1836.com.
	There is a charge of \$40.00 for the ID card to cover the costs incurred. If
	sending a <b>check</b> or <b>money order</b> , make payable to: SOS Mary Reichardt.
	The ID card is valid for 5 years.
	If your card is lost, stolen, needs replacement, or renewal there is a cost of
	\$25.00 for the replacement card.
	If you come to one of these meetings you may also pay for your ID card with
	one and 1/2 oz of silver instead of \$40.00. I wouldn't recommend mailing
	silver but it has been done and you can. We also accept federal reserve
	notes.
