## HOW TO MAKE APPLICATION FOR LIMITED TEXIAN ID CARD Checklist

When filling in your **Limited Texian ID CARD APPLICATION** you must complete the following:

- □ First fill out the "APPLICATION FOR LIMITED TEXIAN ID CARD" form
- □ A **colored copy** of the application must be completed.
- Place a red ink thumbprint above My seal Right Thumb Print (Red Ink) on form
- □ ID cards require a digital image of yourself. A phone image is acceptable if you do not have a digital camera. The image should be a quality head shot, similar to a passport photo. Use an uncluttered, plain, light-colored background. No hats, caps or glasses. This will be the image that will appear on your card for the next 5 years. It's okay to smile!
- □ Send the digital photo to sos@therepublicoftexas1836.com.
- There is a charge of \$75.00 (\$85.00 if outside the united States) for the ID card to cover the costs incurred. If sending a check or money order, make payable to: SOS Mary Reichardt.
- $\hfill\square$  The ID card is valid for 5 years.
- □ If your card is lost or stolen or needs replacement during that time there is a cost of \$40.00 for a replacement card.
- If you come to one of these meetings you may also pay for your ID card with three oz of silver instead of \$70.00. (three and one half oz if outside the united States). I wouldn't recommend mailing silver, but it has been done, and you can. We also accept federal reserve notes.

We have Congressional sessions once a month, which location, date and time are shown on the home page of this website. You can attend these meetings if you wish, to learn more about why and how your government exists and operates.
